TROWBRIDGE, MELKSHAM AND DISTRICT WATER BOARD.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Urban District Councils of Trowbridge and Melksham and the Rural District Councils of Melksham and Westbury and Whorwellsdown for an Act (under the above name or short title) of which the principal subject matters are as follows:—

1. The constitution of a Water Board (hereinafter referred to as "the Board") consisting of representatives of the Urban District Councils of Trowbridge and Melksham and the Rural District Councils of Melksham and Westbury and Whorwellsdown (hereinafter referred to as "the Councils") for the purpose of supplying water in the urban districts of Trowbridge and Melksham and the rural district of Melksham and parts of the rural districts of Westbury and Whorwellsdown and Bradford-on-Avon, in the county of Wilts.

2. To authorise the purchase by the Board compulsorily or by agreement of the undertaking of the Trowbridge Water Company.

3. To confer on the Board all such powers as are usually conferred upon water authorities and water boards.

4. Acquisition of lands and easements by agreement; protection of water and waterworks against contamination; retention and disposal of lands; subsidiary works; application of section 54 of the Public Health Act 1875; rates and charges; powers and provisions incidental to and regulating the supply consumption and use of water and works incidental thereto; alteration of sections 35 and 57 of the Waterworks Clauses Act 1847; supply of water in bulk.

5. Borrowing of money; apportionment of deficiencies and profits; reserve, sinking and other funds and other financial provisions.

6. Incorporation, repeal and amendment of Acts.

CORBY (NORTHANTS) AND DISTRICT WATER.

NOTICE is hereby given that application has been made to Parliament in the present Session for an Act of which the principal subject matters are as follows:—

1. To incorporate a Company (hereinafter referred to as "the Company") and to authorise the Company to construct waterworks and to supply water for all purposes within the following areas (hereinafter referred to as "the limits of supply") namely:—

In the County of Northampton—

In the Rural District of Kettering—

The parishes of Beanfield Lawns, Corby, Cottingham, East Carlton, Geddington, Great Oakley, Great Weldon, Little Weldon, Middleton, Newton and Stanion.

In the Rural District of Gretton—

The parish of Rockingham.

In the County of Leicester—

Part of the parish of Great Easton in the Rural District of Hallaton.

In the County of Rutland—

Part of the parish of Caldecott in the Rural District of Uppingham.

2. The construction and maintenance by the Company of the following waterworks:—

In the Counties of Rutland and Leicester—

Work No. 1.—A reservoir (to be called the Eye Brook Reservoir) to be formed by means of an embankment or dam across the Eye Brook and to be situate in the parishes of Stoke Dry and Caldecott in the rural district of Uppingham in the County of Rutland and in the parishes of Great Easton and Stockerston in the rural district of Hallaton in the County of Leicester.

Work No. 2.—A diversion (No. 1) of the public roads leading from Great Easton to Stoke Dry and from Stockerston to Stoke Dry to be situate in the said parishes of Stoke Dry and Stockerston.
