

In the County of Leicester—

Work No. 3.—An alteration of the level of the public road leading from Great Easton to Stockerston and Stoke Dry to be situate wholly in the said parish of Stockerston.

Work No. 4.—An alteration of the level of the public road leading from Great Easton to Stockerston and Stoke Dry to be situate wholly in the said parish of Stockerston.

Work No. 5.—A diversion (No. 2) of the public road leading from Great Easton to Stockerston and Stoke Dry to be situate in the said parishes of Stockerston and Great Easton.

In the Counties of Rutland and Leicester—

Work No. 6.—A new road or private carriageway to be situate in the said parishes of Caldecott and Great Easton.

Work No. 7.—A line or lines of pipes (No. 1) to be situate in the said parishes of Caldecott and Great Easton.

In the County of Leicester—

Work No. 8.—A pumping station and works for the treatment and filtration of water in the said parish of Great Easton.

In the Counties of Leicester and Northampton—

Work No. 9.—A line or lines of pipes (No. 2) to be situate in the said parish of Great Easton and the parish of Rockingham in the rural district of Gretton.

In the County of Northampton—

Work No. 10.—A line or lines of pipes (No. 3) to be situate wholly in the said Parish of Rockingham.

Work No. 11.—A line or lines of pipes (No. 4) to be situate in the said parish of Rockingham and the parish of Corby in the rural district of Kettering.

Work No. 12.—A line or lines of pipes (No. 5) to be situate wholly in the said parish of Corby.

Work No. 13.—A water tower or elevated service reservoir in the said parish of Rockingham.

3. Power to make subsidiary works; powers of deviation.

4. Appropriation of waters of Eye Brook and other springs streams and waters; Compensation water.

5. Stopping up of parts of public roads footpaths and footbridges in the said parishes of Stockerston Stoke Dry and Great Easton; vesting of intended road diversions in and provisions as to repair of same by road authorities; Extinction of public and private rights of way and other rights.

6. Opening, breaking up etc. of streets roads etc. within and without Company's limits of supply; Power to Company for purpose of supplying water in bulk beyond limits of supply to break up for the purposes of laying pipes part of the public road leading from Kettering northward to Rockingham and Uppingham.

7. Provisions as to acquisition by Company from the Kettering Rural District Council of their waterworks undertaking by which the parishes of Corby and Stanion in the Rural

District of Kettering are supplied with water, or any part or parts thereof, and special provisions as to supply of water therein:

8. Acquisition of lands and easements by compulsion or agreement; Limitation of compensation; Costs of arbitration; Entry on land for purposes of survey and valuation; Retention and disposal of lands; Application of Section 12 of Waterworks Clauses Act 1847.

9. Power to Company to purchase by compulsion or agreement lands comprising two acres three roods or thereabouts in the said parish of Corby in the County of Northampton, lands comprising one hundred and ninety acres or thereabouts in the said parish of Great Easton in the County of Leicester, and lands comprising twenty acres four roods or thereabouts in the said parish of Caldecott in the County of Rutland.

10. Temporary occupation of lands; Protection of waters and waterworks against contamination; Rates rents and charges; Terms and conditions of supply; Filtration; Provisions as to mains and communication pipes, common pipes, meters, valves, etc.; Pressure; Cisterns etc.; conferment on Company of all powers usually conferred upon water undertakers including power to supply meters and fittings; Powers and provisions regulating the supply consumption and use of water and works incidental thereto; Alteration of Section 35 of Waterworks Clauses Act 1847; Supply and purchase of water in bulk; Byelaws.

11. Definition of capital and borrowing powers of Company; payment of interest out of capital and charge to capital of interest on borrowed moneys; Provisions as to directors, auditors, voting, meetings; dividends, accounts and administrative matters.

12. Incorporation and amendment of Acts.

Duplicate plans and sections describing the situation lines and levels of the intended works and the lands in or through which the same will be made and the lands and property to be taken or used compulsorily under the powers of the intended Act together with a Book of Reference to such plans were deposited for public inspection on or before the 20th November 1930 with the Clerk to the Northampton County Council at his office at Northampton, with the Clerk to the Leicester County Council at his office at Leicester, and with the Clerk to the Rutland County Council at his office at Oakham and on or before the same day a copy of so much of the said plans sections and book of reference as relates to each of the several areas hereinafter mentioned were deposited as follows:—
