HACKNEY BOROUGH COUNCIL.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Mayor, Aldermen and Councillors of the Metropolitan Borough of Hackney (hereinafter referred to as "the Council") for an Act (under the above name or short title) of which the principal subject matters are as follows:—

1. The execution of street works in the Metropolitan Borough of Hackney, including a new street communicating with Reading Lane, a widening of Reading Lane and the stopping up of part of Hackney Grove.

2. The compulsory acquisition of lands in the said Borough for the street works referred to in the last preceding paragraph and for the extension of the present Town Hall.

3. To provide for the extension of the Town Hall and the provision and erection of all necessary and incidental buildings.

4. The alteration and amendment of the Camberwell and other Metropolitan Borough Councils (Superannuation) Act, 1908, and section 49 of the London County Council (General Powers) Act, 1929, so far as the same relate to the said Borough, and also of the Hackney Borough Council Act, 1926, in regard to superannuation and other allowances to the officers and servants of the Council including the prescription of a new scale of allowances and benefits for new entrants, and in certain cases for existing officers and servants; altered rates of contribution; transfer values and payments in lieu of transfer values; return of contributions and other payments; allowances to employees possessing special qualifications and alteration of provisions in regard to superannuation fund and actuarial investigations.

5. The borrowing of money for the several purposes of the Bill and further and better provision in regard to the finances of the Council and other financial matters.

6. The transfer and vesting in the Council of the disused Church Tower in the Churchyard of Saint John at Hackney on the east side of Mare Street in the said Borough.

Plans and sections of the intended works and plans of the lands intended to be taken together with a book of reference thereto were on or before the 20th day of November, 1930, deposited with the Clerk of the London County Council at his office at the County Hall, London, S.E. 1, and with the undersigned Town Clerk of the said Borough at the Town Hall, Hackney, London, E. 8.

On and after the 4th day of December, 1930, a copy of the Bill may be inspected and copies thereof obtained at the price of 2s. 6d. each at the offices of the undersigned Town Clerk and Parliamentary Agents.

WEST HAM CORPORATION.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Mayor Aldermen and Burgesses of the County Borough of West Ham (hereinafter referred to as "the Corporation") for leave to introduce a Bill (hereinafter referred to as "the Bill") of which the principal subject matters are as follows:—

Compulsory acquisition by the Corporation of lands in the said County Borough of West Ham (hereinafter referred to as "the Borough") for (a) the erection thereon and on other lands adjoining the same and belonging to the Corporation of offices and buildings for municipal and other public purposes, and (b) the widening of Greengate Street.

Acquisition of parts only of certain properties; exemption from Sections 92 and 127 of the Lands Clauses Consolidation Act 1845 and other modifications of Lands Clauses Acts; entry upon lands and buildings for survey &c.; limitation of compensation payable in certain cases; agreements for sale and exchange and for reinstatement of owners of lands or property; extinguishment of private rights of way over lands acquired compulsorily; further powers with respect to the retention and disposal of lands; acquisition of lands for public purposes in advance of requirements.

Exemption of lands from time to time owned or occupied by the Corporation from certain covenants conditions restrictions or stipulations and release of the Corporation and other parties from covenants to comply therewith.

Supply by Corporation of electricity to companies or bodies having undertakings partly within and partly without the Borough and use by such companies and bodies of electricity so
