SEATON URBAN DISTRICT COUNCIL.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Seaton Urban District Council (hereinafter referred to as "the Council") for an Act of which the principal subject matters are as follows:—

Power to the Council to make and maintain waterworks in the parish of Colyton in the Rural District of Axminster and in the Urban District of Seaton in the County of Devon comprising the following:—

Work No. 1.—An intake and weir in the said parish of Colyton to be constructed across the Holyford Brook in the enclosure numbered 1555 on the ¹/₂₅₀₀ Ordnance Map of Devonshire Sheet LXXXIII-7 Second (Edition 1904).

Works Nos. 2 and 3.—Two catchwater drains or lines of pipes one in the parish of Colyton commencing in the enclosure numbered 1491 and the other in the parish of Colyton and urban district of Seaton commencing in the enclosure numbered 3 on the said ordnance map and both terminating in Work No. 1.

Work No. 4.—A line or pipes from Work No. 1 to the existing main of the Council in Sidmouth Street, Seaton.

Work No. 5.—A line of pipes from Work No. 4 to Work No. 6.

Work No. 6.—A tank or service reservoir in the Urban District of Seaton in the enclosure numbered 89 on the said ordnance map.

Work No. 7.—A line of pipes from Work No. 6 to the existing main of the Council in Marlpit Lane, Seaton.

Powers of deviation, compulsory acquisition of and other powers as to lands, easements, etc. in parish aforesaid including acquisition compulsorily or by agreement of certain lands in the said parish of Colyton consisting of the enclosures numbered 1376, 1402 to 1404, 1406 to 1409, 1491, 1550 to 1565 and 1570 on the ¹/₂₅₀₀ Ordnance Map Devonshire Sheets LXXXIII. 6

and 7 (Edition of 1904) and in the Parish and Urban District of Seaton consisting of the enclosures numbered 2, 3, 4, 48, 49 and 50, and parts of the enclosures numbered 6, 8, 10, 12, 14, 16, 17, 19 and 89 on the said sheets of the said Ordnance Map.

Power to Council to take, intercept, divert, collect, use and appropriate the waters of the Holyford Brook and all the tributaries, springs, streams, and waters which flow directly or indirectly into the said Brook and which can be intercepted by the Works hereinbefore described, or can be found on any of the lands for the time being belonging to the Council and to use such waters for the purposes of their water undertaking.

To empower the Council to provide gauges on the Holyford Brook for measuring the flow; to discharge water into any available sewers streams or watercourses; to make provision for the protection and benefit of landowners, mill owners &c.; to authorise agreements with landowners with respect to drainage of lands within drainage area of works, and as to construction of works required for protection of sources of water supply; to make provision for prevention of pollution and contamination of the water and to make byelaws for such purposes and impose obligations and restrictions.

To enable the Council to lay down and maintain aqueducts, conduits, pipes, and other works and to break up streets within the limits of supply.

To authorise the Council to supply water throughout the Urban District of Seaton and (in the event of the purchase of the water undertaking of the Rolle Estate hereinafter referred to) within the Parish of Beer in the Rural District of Axminster.

Rates, rents and charges; Terms and conditions of supply; Pressure; Cisterns; Conferment upon Council of all powers usually conferred upon water undertakers including power to supply fittings; Powers and provisions incidental to and regulating the supply, consumption and use of water and works incidental thereto; Alteration of Section 35 of Waterworks Clauses Act 1847.

Purchase by agreement of the water undertaking of the Rolle Estate; maintenance and extension of works comprised in the said undertaking, rates and charges for supply in Parish of Beer after the purchase of the said undertaking; exemption from liability to supply in the said parish above a certain altitude.

Borrowing of money, the mode of raising same and incidental provisions in regard thereto; supply of water in bulk; Application of revenues and profits, and enactment of provisions in regard to financial matters generally.

Incorporation, amendment and repeal of Acts.

Plans and sections relating to the intended works and plans of the lands which may be taken compulsorily under the powers of the Bill with a book of reference to such plans were deposited for public inspection on or before the 20th day of November 1930 with the Clerk to the County Council of Devon at his office at Exeter and on or before the same day a copy of so much of the said plans, sections, and book of reference as relates to
