

Quarter Sessions Recorder and other officers of the City and of powers and duties of justices of the Peace and Coroner of the Borough of Newcastle-under-Lyme; the application modification and repeal or amendment of local Acts and Orders in force in the City and the added area; application to the extended City of adoptive Acts byelaws regulations and tables of fees in force in existing City and/or the added area; preparation of local government electors and jurors lists alteration of assessment areas and areas of public assistance committees; transfer and adjustment of property and adjustment of financial relations; liquidation of debts and liabilities; differential rating; vacation of office by managers of schools; provisions with regard to teachers; continuation of free libraries; constitution of Corporation as Burial Board for the extended City; transfer of and compensation to officers; alteration of constitution of joint boards or committees; the borrowing of money and other matters.

CITY OF LONDON (VARIOUS POWERS).

NOTICE is hereby given that application is being made to Parliament in the present Session by the Mayor Aldermen and Commons of the City of London in Common Council assembled (hereinafter referred to as "the Corporation") for an Act, under the above name or short title, of which the principal subject matters are as follows:—

1. Constitution of a new Superannuation Fund for the officers and servants of the Cor-

poration and the transfer to such fund of the members and annuitants and the assets and liabilities of the superannuation and pension funds established by the City of London (Various Powers) Act 1912.

2. Re-enactment with the necessary adaptations and additions of the provisions of the said Act and of the City of London (Various Powers) Acts 1914 and 1922 with reference to all existing superannuation and pension funds of the Corporation.

3. Application of new superannuation fund to officers and bailiffs and criers of the Central Criminal Court.

4. Further byelaws for the government of the Metropolitan Cattle Market, and the provision and regulation of parking places thereat.

5. Byelaws as to projections into and over streets and searchlights, floodlights and intermittent illuminations.

AMALGAMATED SOCIETIES FOR THE BLIND.

NOTICE is hereby given that application is intended to be made to Parliament in the present Session by the London Society for Teaching and Training the Blind (Incorporated) (hereinafter called "the London Society") and the Incorporated Association for promoting the General Welfare of the Blind (hereinafter called "the Incorporated Association") for an Act of which the principal subject matters are the following:—

To amalgamate unite and incorporate the London Society and the Incorporated Association and the persons who at the date of the passing of the intended Act shall be members of the said Society and Association in one body corporate (hereinafter called "the Society") by the name of the Amalgamated Societies for the Blind or such other name as shall be prescribed by the intended Act to provide for the transfer to and vesting in the Society of all property belonging to or held by the London Society or the Incorporated Association or belonging to any Charity subsidiary or ancillary to either and to make provision as to property held in trust; to authorise the Society to acquire and hold property in perpetuity or otherwise; to make provision for the taking effect of bequests or gifts under existing or future wills or instruments; to declare the objects of the Society to prescribe the qualifications of members and life members
