MERCHANDISE MARKS ACT, 1926.

In accordance with the provisions of Section 2, Sub-section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of applications received by them for the making of Orders in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following classes and descriptions of imported goods :—

(1) Polishing wheels, discs and bobs made wholly or mainly of felt;

(2) Slider fasteners of the type commonly known as Zip or Lightning Fasteners, i.e., consisting of two flexible stringers comprising a series of metal members which are progressively locked or unlocked by the action of a slider.

Attention is called to the fact that, while, under the provisions of the above Act, the Committee must in every case referred to them

consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.
