ASHTON-UNDER-LYNE STALYBRIDGE AND DUKINFIELD (DISTRICT) WATERWORKS.

NOTICE is hereby given that application has been made to Parliament in the Session 1930-31 by the Ashton-under-Lyne Stalybridge and Dukinfield (District) Waterworks Joint Committee (hereinafter called "the Committee") for an Act of which the principal subject matters are as follows:—

- 1. Increases in the contributions to be made to the funds of the Committee by the constituent authorities (namely the mayors aldermen and burgesses of the boroughs of Ashton-under-Lyne Stalybridge Dukinfield and Mossley and the urban district council of Audenshaw); the conferring of further borrowing powers for the purpose of meeting such contributions upon the constituent authorities.

Further provisions as to waterworks including provisions as to the discharge of water into streams, the construction of tanks under streets, the laying down of meters in streets and waterpipes in private streets, the construction of dwelling-houses and other buildings for employees of the Committee and other purposes, and the application to telephones discharge pipes and other apparatus of the provisions of the Waterworks Clauses Act 1847 as to breaking up streets.
