COVENTRY EXTENSION.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Mayor, Aldermen and Citizens of the City of Coventry (hereinafter respectively called "the Corporation" and "the City") for an Act, of which the principal subject matters are as follows:—

1. The alteration and extension of the boundary of the City and of the parish of Coventry so as to include within the boundary of that City and parish the following areas (hereinafter called "the added areas") all in the administrative County of Warwick, namely:—

The parishes of Binley, Exhall, Foleshill, Keresley, Walsgrave-on-Sowe, Willenhall and Wyken in the Rural District of Foleshill, the parish of Coundon and the part of the parish of Allesley, delineated on the map hereinafter referred to, in the Rural District of Meriden, and the parishes of Baginton and Stivichall, and the part of the parish of Stoneleigh, delineated on the said map, in the Rural District of Warwick. The said parts of parishes are delineated on the map deposited as hereinafter mentioned, and are defined in the second schedule to the Bill, which can be inspected and obtained as hereinafter mentioned.

- 2. The dissolution of the parish councils of the existing parishes of Binley, Exhall, Foleshill, Keresley, Walsgrave-on-Sowe, Willenhall, Wyken, Coundon, Baginton and Stivichall, and the exclusion of the added areas from the jurisdiction of the Warwickshire County Council, the Foleshill, Meriden and Warwick Rural District Councils, and the Allesley and Stoneleigh parish Councils, so far as those areas or any of them are within the jurisdiction of any of those authorities.
- 3. Provision for the Warwickshire County Council (a) to submit modifications of the proposals already made by them under section 46 of the Local Government Act 1929 to deal with the local government of the parts of the said rural districts not included in the city, and the transfer of property and liabilities of the said rural district councils and parish councils in respect of the parts of their areas not included in the city and other matters; and (b) to submit proposals to the Secretary of State with regard to county electoral divisions affected by the intended Act and their representatives.
- 4. The enactment of all necessary convenient or consequential provisions with regard to

such alterations or extensions, including provisions as to Local Government elections; number of Councillors and Aldermen of the City; the alteration and increase of wards in the City; the election and retirement of Councillors and Aldermen; the extension of jurisdiction of officers of the Corporation, and of Justices and peace officers; the alteration of county electoral divisions; the extension and amendment of local Acts and Orders etc.; provision with regard to the powers and jurisdiction of the Coroners for the northern and central divisions of the County of Warwick, and the appointment of Coroners by the Corporation for the areas of the City within such Coroners' divisions, on the death, resignation or removal from office of the present Coroners for those divisions; the transfer and adjustment of property, and provision as to mort-gage and other debts of the County Council and other councils in the added areas; the liquidation of debts; provision as to differential rating in the added areas; the transfer of schools; the transfer of police and police stations; the transfer of officers and the abolition of office and compensation for loss; the transfer to the Insurance Committee of the City of certain of the property, rights and liabilities of the County Insurance Committee; the modification of town planning schemes and proposed schemes and the transfer to the Corporation of powers relating thereto; the alteration of registers of local land charges, and nursing homes; valuation lists; the application of the Rating and Valuation Act, 1925; Electors Lists; registration of electors; Contribution Orders, precepts and arrears of rates; administration of Registration Acts; settlement and removal of poor persons, and other matters.

- 5. The alteration of the number of members of the Warwickshire and Coventry Joint Committee for tuberculosis; the determination of the manner in which deficiencies in the fund of that Committee should be met, and other provisions in connection with that Committee.
- 6. The transfer of the cemetery provided in the parish of Walsgrave-on-Sowe to the Corporation, with power to repeal any byelaws etc. in force with respect to the said cemetery.
- 7. The borrowing of money by the Corporation for the purposes of the intended Act and other financial matters.
- 8. The Incorporation, repeal or amendment of Acts (both general and local) and Orders, and the enactment of all such provisions as may be incidental to the objects of the intended Act, and consequential thereon.

A map, in duplicate, showing as well the present boundaries of the City as the boundaries of the proposed extension, was on the 20th day of November last, deposited with the Town Clerk of the City at his office at the Council House, Coventry.

On and after the 4th day of December instant a copy of the Bill may be inspected, and copies thereof obtained at the price of three shillings and sixpence per copy at the said office of the Town Clerk and at the offices of the undermentioned Parliamentary Agents.
