5. Power for the Corporation to purchase by compulsion or agreement the following lands:—

(a) For the purposes of Section 154 of the Public Health Act 1875—

Lands in the borough in and near Cann Street, Shuttern, Station Road, Leycroft Road, and East Reach.

(b) For the purpose of constructing an aerodrome and for other the purposes of the aerodrome undertaking of the Corporation—

Lands in the Parishes of St. Mary Magdalene Without and Ruishton in the rural district of Taunton in the County of Somerset.

- 6. The application of the provisions of the Markets and Fairs Clauses Act 1847, with certain exceptions, to the market of the Corporation, and the repeal of the Taunton Town and Market Regulations Acts, the appropriation of certain of the market lands for the purposes of a public walk and pleasure ground, and further provisions with regard to the erection and letting of buildings in, and the regulation and use of, the Corporation's market.
- 7. Further and better provision with regard to streets buildings, sewers and drains within the borough, the prevention of infectious and other diseases, sanitary matters and common lodging houses.
- 8. The extension of the Town Planning Act 1925 to Lands wholly or partly developed.
- 9. Further provision with regard to hackney carriages certain police matters and the good government of the Borough, including the prohibition or regulation of vehicles passing through Castle Bow in the Borough and the prohibition or restriction of the use of bicycles etc., in Chip Lane, Obridge Path, Hammet's Walk and Castle Walk and other footpaths in the Borough.
- 10. Power for the Corporation to break up the roads over certain bridges in the parish of West Monkton in the rural district of Taunton in the County of Somerset for the purpose of supplying electricity; and other general powers with regard to the supply of electricity.
- 11. The extension of the boundary of the borough so as to include therein in addition to the existing Borough, parts of the parishes of Trull, St. Mary Magdalene Without, West Monkton, Ruishton, St. James Without and Staplegrove, in the rural district of Taunton in the County of Somerset, and the extension of the parish of Taunton to include the same areas; the separation of the said parts of parishes from the said rural district, the addition of excluded parts of parishes to other parishes, and the enactment of all necessary provisions consequent upon the alteration of the boundary of the said borough.

12. The enactment of all further provisions consequential upon and incidental or supplemental to the proposals before mentioned, including the extension, amendment and repeal of local Acts, adoptive Acts, Orders and Byelaws etc.; alteration of the wards of the borough and county electoral divisions; town planning; property and liabilities of the Corporation and the Council of the said rural district and the councils or chairmen of parish

meetings of the said parishes; financial adjustment; differential rating; alteration of joint boards and committees and assessment and insurance committees; valuation lists; registers; officers and their compensation; borrowing of money and other matters.

13. The borrowing of money for all or any of the purposes of the intended Act, and other financial provisions, including the establishment of a consolidated loans fund and a lands fund; provision with regard to the revenue and expenses of the Corporation's undertakings and the accounts thereof; and the use of moneys standing to the credit of any sinking or other fund instead of borrowing.

Plans and sections of the works and plans of the lands intended to be taken for the purposes of the intended Act, together with a book of reference to the plans, were on or before the 20th day of November last deposited for public inspection with the Clerk of the County Council of the Administrative County of Somerset at his office in Weston-super-Mare, and a copy of so much of the said plans, sections and book of reference as relates to each of the several areas hereinafter mentioned were on or before the said 20th day of November deposited as follows:—

As relates to the Borough of Taunton, with the Town Clerk of the Borough at his office therein;

As relates to the Rural District of Taunton, with the Clerk to the Taunton Rural District Council at his office at Mary Street House, Taunton;

As relates to the Rural District of Wellington, with the Clerk to the Wellington Rural District Council at his office at the Register Office, Wellington;

As relates to the Parish of Corfe, with the Clerk to the Parish Council of that Parish at his office at Trull;

As relates to the Parish of Otterford, with the Clerk to the Parish Council of that Parish at his office at Bishopswood, Otterford;

As relates to the Parish of Pitminster, with the Clerk to the Parish Council of that Parish at his office at Staplehay, Pitminster;

As relates to the Parish of Ruishton, with the Clerk to the Parish Council of that Parish at his office at Henlade;

As relates to the Parish of West Buckland, with the Clerk to the Parish Council of that Parish at her office at West Buckland:

As relates to the Parish of St. Mary Magdelene Without, with the Chairman of the Parish Meeting of that Parish at his residence at Killows, Shoreditch, Taunton.
