## MIDDLESEX COUNTY COUNCIL.

- 2. Powers as to subsidiary works, deviations, alterations, diversions and stopping up of roads, tramways, sewers or mains.
- 3. Acquisition of land and easements, including 13½ acres of Shortwood Common and 1½ acres of Ickenham Green for the purpose aforesaid and other purposes, in the boroughs, districts and counties aforesaid, modification of the Lands Clauses Acts and provisions as to the entry on lands and limiting compensation.
- 4. The application to the Council of all or some of the provisions of the Public Health Acts relating to sewers and sewage and the conferring on them of powers under those provisions.
- 5. Power to Council to permit or require any of the following local authorities (hereinafter referred to as "the said authorities") to discharge the sewage of their districts into the Council's sewers:-the Ealing Corporation, the Twickenham Corporation, the councils of the urban districts of Brentford and Chiswick, Feltham, Hampton, Hampton Wick, Harrow-on-the-Hill, Hayes and Harlington, Hendon, Heston and Isleworth, Kingsbury, Ruislip - Northwood, Southall - Norwood, Staines, Sunbury-on-Thames, Teddington, Ux-bridge, Wealdstone, Wembley, and Yiewsley and West Drayton and the Hendon Rural District Council, provisions in reference to those powers including alteration of any sewerage system, discharge of effluents and storm waters into the Thames and other rivers, regulations as to trade refuse; restrictions on the use of the Council's sewers and sewers connected with them and provisions for the prevention of injury to or interference with such sewers and the prohibition of unauthorised communications therewith.
- 6. Agreements between the Council and any local authority within or without the county as to the use of the Council's sewers for the disposal of sewage from such authority's district and other matters.
- 7. Transfer to the Council of disused sewage works of the said authorities and of rights and obligations with regard thereto.
- 8. Borrowing of money, expenses incurred by local authorities and other financial matters.
