6. The enactment of further provisions with regard to streets, buildings, tents, vans, sheds, hoardings, temporary stands, banners and signs over streets, means of escape from fire, food storage accommodation, provision of baths, precautions to prevent gas poisoning, sewers, drains, sanitary conveniences, infectious disease, registration of ice-cream manufacturers and their premises, inspection of such premises, private wells in and under dwelling-houses, filthy premises, dustbins and ashpits, stables, slaughterhouses, transport of food, offensive trades and refuse.

7. The borrowing of money by the Corporation for the purposes of the Bill and other financial matters including the use of funds for borrowing, the investment of funds, the establishment of a consolidated loans fund, the payment of dividends and interest by post, the application of revenues and payment of expenses of undertakings of the Corporation, the establishment of reserve funds, the appointment of auditors, the establishment of an insurance fund, power to carry out a scheme for fixing equated periods for loans, the creation of capital, reserve and renewals and repairs funds and other financial and miscellaneous matters.

8. Provisions for altering the title of the Corporation and for authorising them to accept gifts and bequests.

9. Empowering the Corporation to advertise the borough.

10. Authority to the Corporation to charge for admission to their lands and buildings.

11. The enactment of provisions for regulating or preventing the holding of pleasure fairs and of provisions as to nuisances from noise.

12. Enactment of further provisions as to acquisition by the Corporation of lands by agreement for the benefit of the borough and for the exercise of their powers and duties; the erection of dwellinghouses etc. for persons in the Corporation's employment.

13. The amendment and extension of section 11 of the Rating and Valuation Act, 1925, in regard to property of the Corporation and otherwise and the recovery of rates from persons removing.

14. The incorporation, repeal and amendment of Acts and Orders, both general and local, and the enactment of all incidental, convenient and consequential provisions.
