TAMWORTH CORPORATION.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Mayor Aldermen and Burgesses of the Borough of Tamworth (hereinafter called "the Corporation" and "the Borough" respectively) for an Act of which the principal subject matters are as follows:—

the principal subject matters are as follows:—
1. The extension of the borough by the inclusion of the following parishes all in the Rural District of Tamworth:—

- (a) Fazeley, Wigginton and Hopwas Hayes in the Administrative County of Stafford; and
- (b) the parish of Amington and Stonydelph, the parish of Bolehall and Glascote, and the parish of Wilnecote and Castle Liberty in the Administrative County of Warwick,

(hereinafter called "the added areas"); extension of the parish of Tamworth to include the added areas; separation of the parishes of Amington and Stonydelph, Bolehall and Glascote, and Wilnecote and Castle Liberty from the County of Warwick; alteration of county boundary so that the extended borough will be wholly in Staffordshire.

2. Abolition of the parish councils of the parishes comprising the added areas and the removal of the said parishes from the jurisdiction of the Tamworth Rural District Council (hereinafter called "the rural council").

3. Division of extended borough into wards

Division of extended borough into wards and the enactment of all provisions consequential upon and incidental or supplemental to the proposals before mentioned including the extension, amendment and repeal of Local Acts, Adoptive Acts, Orders and Byelaws; alterations in the constitution, powers and duties of any authorities affected by the proposals; financial adjustments, compensation to officers, alteration of joint boards and committees, settlement and removal of the poor.
- 4. The modification and amendment of the South Staffordshire Joint Smallpox Hospital 1928, and the Tamworth Order Joint Hospital Order 1896 and the Acts con- \mathbf{those} firming Orders respectively, alteration of the representation of the Corporation and the rural council on the Joint Boards constituted thereunder; the annulment, modification or amendment of an agreement dated the 19th October, 1905 between the Corporation and the rural council constituting the Joint Sewage Disposal Committee and of an agreement dated the 31st January, 1880 between the Corporation and the Rural Sanitary Authority of the Tamworth Union as predecessors of the rural

council constituting the Joint Waterworks Committee, the dissolution of each of the said Joint Committees, the transfer of all property and liabilities of the said Joint Committees to the Corporation; the conveyance to the Corporation by the rural council of their estate and interest in any land premises and works purchased or provided for the purpose of the said Joint Waterworks Committee or agreement; provisions entitling the rural council notwithstanding the dissolution of the said Joint Waterworks Committee to receive a supply of water from the Corporation for purposes of supply within the Parish of Shuttington and part of the Parish of Kingsbury; the modification or amendment of an agreement dated the 29th November, 1926 between the Corporation and the rural council and of a supplemental agreement dated the 20th February, 1928 between the Corporation, the rural council and the Polesworth Parish Council relating to the Joint Fire Committee; alteration of the representation of the parties on the said Joint Fire Committee and enactment of provisions as to the proportions in which expenditure incurred by the said Joint Committee shall be borne.

- 5. The constitution of the Corporation as the Burial Board or Burial Authority for the enlarged borough; the dissolution of the Wilnecote United District Burial Board; the transfer to and vesting in the Corporation of all property and liabilities of such Board and of the Bolehall and Glascote Parish Council as a Burial Authority.
- 6. Further provision with regard to hackney carriages and with regard to the control of traffic and other police matters and the good government of the borough.
- 7. Further and better provision with regard to streets, buildings, sewers and drains, petroleum filling stations, slaughter houses and common lodging houses, for the prevention of infectious and other diseases and with reference to sanitary matters, the sorting and tipping of refuse and for securing the purity of food.
- 8. The provision of and further powers with regard to swimming and other baths and bathing pools and the user of swimming baths belonging to the Corporation for exhibitions, entertainments, etc.
- 9. Further provisions with regard to the acquisition and development of land.
- 10. The borrowing of money for all or any of the purposes of the intended Act, and other-financial provisions, including the establishment of a lands fund and the substitution of professional auditors for the borough auditors; the granting of gratuities and allowances to officers. and servants and their families in certain cases.
- 11. The incorporation, repeal and amendment of Acts and Orders and enactment of incidental and miscellaneous provisions including powers as to the erection of a Town Hall and Municipal Buildings and the erection of shops, etc., in connection therewith and leasing of the same.

A map in duplicate showing the present boundaries of the borough and the boundaries of the proposed extension together with a map showing the proposed division of the extended borough into wards was deposited on the 20th November 1930 with the town clerk of theborough at his office therein for public inspection.
