## SHOREDITCH ELECTRIC LIGHTING ORDER, 1892. LONDON ELECTRIC SUPPLY ACT, 1908.

WHEREAS the Metropolitan Borough Council of Shoreditch (hereinafter referred to as "the Council") under the powers conferred by Section 8 of the London Electric Supply Act, 1908, are supplying electrical energy at a point within the Council's area of supply to the London and North Eastern Railway Company (hereinafter referred to as "the Railway Company") for the purposes of haulage or traction:

NORTH WANSBECK ELECTRICITY.

NOTICE is hereby given that the Newcastleupon-Tyne Electric Supply Company Limited whose registered office is at Carliol House, Newcastle-upon-Tyne (hereinafter referred to as "the Applicants") have applied to the Electricity Commissioners under the Electricity (Supply) Acts, 1882-1928, for a Special Order (hereinafter called "the intended Order") for all or some of the following amongst other purposes, that is to say:-

1.—(a) To authorise the Applicants to supply electricity for all public and private purposes as defined by the above Acts within the following area (hereinafter called "the area of supply"):—

The Parishes or Townships of Angerton Low, Angerton High, Bullock's Hall, Bockenfield, Bigge's Quarter, Benridge, Chevington East, Chevington West, Cambo, Corriage, Causeway Park, Cockle Park, Cresswell, Deanham, Eshott, Edington, Earsdon, Earsdon Forest, Ellington, Freeholders' Quarter, Fenrother, Hudston, Hartburn, Hartburn Grange, Highlaws, Highlaws High and Low, Hebron, Longwitton, Longshaws, Longhirst, Lynmouth, Middleton South, Middleton North, Meldon, Molesden, Mitford, Netherwitton, Newton Underwood, Nunriding, Newton Park, Newminster, Old Moor, Pigdon, Rivergreen, Riddell's Quarter, Sheepwash, Stanton, Spital Hill, Thirston East and West with Shothaugh, Todridge, Thornton West Thornton East, Throphill, Tranwell, Tritlington, Ulgham, Witton Shields, Whitridge, Wallington Demesne, Widdrington, Land common to Bigge's, Freeholders', and Riddell's Quarters, and Fenrother, and Land common to Bigge's, Freeholders', and Riddell's Quarters, in the Rural District of Morpeth all as respectively constituted at the commencement of this Order.

(b) To incorporate with the intended Order (with or without modifications or exemptions) all or any of the provisions of the Electric Lighting (Clauses) Act, 1899, and of the Acts and portions of Acts incorporated therewith and to confer on the Applicants all such powers as may be necessary for effecting the objects of the undertaking and to alter, vary or extinguish all rights and privileges which would or might interfere with such objects.

2. The following are the streets and parts of streets in which it is proposed that electric lines shall be laid down within a specified time:---

In the Parish of Ulgham-

at Widdrington Station— Palmer Terrace; Liddell Terrace; Sanderson Terrace; Lambert Terrace.

In the Parish of East Chevington-

- at Broomhill— Stone Row; Railway Row.
- at South Bromhill— The main road from the Wesleyan Methodist Church to Chevington Vicarage. at Red Row—

Swarland Terrace.

In the Township of East and West Thirston with Shothaugh—

at West Thirston—

The Peth from the Northumberland Arms Inn to the bridge over the Coquet at Felton.

Road from West Thirston to East Thirston from its junction with the Peth to the Electric Sub-station.

3. The Applicants propose to take special powers by the Special Order to break up certain streets and parts of streets and footpaths not repairable by the local authority and certain railways all of which streets and railways are specified in the Third Schedule to the draft Special Order.
