Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a Consolidated Chapelry to the consecrated Church of Saint Michael and All Angels, Knighton, situate within the New Parish (sometime District Chapelry) of Saint John the Baptist, Knighton, in the County of Leicester and in the Diocese of Leicester:

"Whereas at certain extremities of the said New Parish of Saint John the Baptist, Knighton, and of the New Parish (sometime Consolidated Chapelry) of All Souls, Leicester, in the said County and Diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such New Parishes:

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said New Parish of Saint John the Baptist, Knighton, and of the said New Parish of All Souls, Leicester, should be formed into a Consolidated Chapelry for all Ecclesiastical purposes, and that the same should be assigned to the said Church of Saint Michael and All Angels, Knighton, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Cyril Charles Bowman, Bishop of Leicester, as such Bishop, and also as the Patron, in right of his See, as well of the Vicarage of the said New Parish of Saint John the Baptist, Knighton, as of the Vicarage of the said New Parish of All Souls, Leicester (in testimony whereof he has signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said New Parish of Saint John the Baptist, Knighton, and of the said New Parish of All Souls, Leicester, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Michael and All Angels, Knighton, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Michael and All Angels, Knighton.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet.

"The Schedule to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Michael and All Angels, Knighton, comprising:—

"All those contiguous portions of the New Parish (sometime District Chapelry) of Saint John the Baptist, Knighton, and of the New Parish (sometime Consolidated Chapelry) of All Souls, Leicester, both in the County of Leicester, and in the Diocese of Leicester,

which, taken together, are bounded upon part of the west by the Parish of Saint James, Aylestone Park, upon the south by the New Parish of Saint Mary Magdalen, Knighton, both in the said County and Diocese, and upon the remaining sides, that is to say, upon the east, upon the north, and upon the remaining part of the west by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mary Magdalen, Knighton, from the said New Parish of Saint John the Baptist, Knighton, at the junction of Houlditch Road and Oraighill Road, and extending thence northward along the middle of Craighill Road for a distance of 81 chains or therealbouts to its junction with Gainsborough Road, and extending thence westward along the middle of Gainsborough Road for a distance of 12 chains or thereabouts to its junction with Raeburn Road, and extending thence northward along the middle of Raeburn Road for a distance of 61 chains or thereabouts to its junction with Greenhill Road and Lorne Road, and extending thence north westward along the middle of Lorne Road (thereby crossing the boundary which divides the said New Parish of Saint John the Baptist, Knighton, from the said New Parish of All Souls, Leicester) for a distance of 241 chains or thereabouts to its junction with Victoria Park Road, and extending thence first south westward and then north westward along the middle of Victoria Park Road for a distance of 8 chains or thereabouts to its junction with Welford Road, and extending thence south eastward along the middle of Welford Road for a distance of 5 chains or thereabouts to the point where it is crossed by the boundary which divides the said New Parish of All Souls, Leicester, from the said New Parish of Saint John the Baptist, Knighton, and extending thence south westward along the said boundary for a distance of 19½ chains or thereabouts to the point where it crosses the middle of the Leicester and Burton Branch Line of the London Midland and Scottish Railway, and extending thence first south westward and then north westward along the middle of the said line of railway (thereby again crossing the boundary which divides the said New Parish of Saint John the Baptist, Knighton, from the said New Parish of All Souls, Leicester), for a distance of 23½ chains or thereabouts to the centre of the bridge which carries such railway across the new road leading from Aylestone Road to Knighton Lane, and extending thence south eastward along the middle of such new road for a distance of 13 chains or thereabouts to the point where it is crossed by the boundary which divides the said New Parish of All Souls, Leicester, from the said New Parish of Saint John the Baptist, Knighton, and extending thence south westward along such boundary for a distance of 2 chains or thereabouts to the boundary which divides the said New Parish of Saint John the Baptist, Knighton, from the said Parish of Saint James, Aylestone Park."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and
