LAND DRAINAGE ACT, 1918.

*River Welland Drainage Board.*

Notice is hereby given that the Ministry of Agriculture and Fisheries has settled and made an Order under the Land Drainage Act, 1918, empowering the above-named Drainage Board to borrow, on the security of the rates leviable by them, and to repay over a period of 50 years, an additional sum of £20,000 to meet the cost of certain works to be carried out at the mouth of the River Welland, and that the Order will become final and have effect as an Act of Parliament, unless within thirty days from the date of this Notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Ministry by some person or body affected by the Order and having such interest as is prescribed by Article 4 of the Land Drainage Regulations, 1918 (Statutory Rules and Orders, 1918, No. 1605), as being sufficient for the purpose.
