Rules relating to deposits by Assurance Companies under Section 2 of the Assurance Companies Act, 1909, hereinafter referred to as the "Rules of 1910":

And whereas the Board of Trade by Order dated the eighth day of October, 1930, (b) directed that the Rules of 1910 should apply to all Assurance Companies who carry on or intend to carry on motor vehicle insurance business subject to the modifications therein contained:

And whereas by Rule 4 (b) of the Rules of 1910 it is provided that where a lodgment of money or securities has been made under those Rules, the Court may, on the application of the Company, order payment to the Company of the interest, dividends, or income from time to time accruing due on any stocks, funds, or securities in which the deposit is for the time being invested:

Now therefore the Board of Trade, in pursuance of the powers conferred on them by Section 2 of the Assurance Companies Act, 1909, and of every other power in that behalf them thereunto enabling, do hereby make the following Rules:—

- (1) The following addition shall be made to Rule 4 (b) after the word "invested":—
  - "other than the interest, dividends, or income from time to time accruing due on stocks, funds, or securities brought into Court pursuant to Rule 2".
- (2) These Rules shall come into force on the first day of January, 1931.
