"4. That the fees for Marriages, Churchings, and Burials and other Ecclesiastical dues, offerings and emoluments received within the said Portion of the Parish so transferred shall henceforth belong to the Incumbent of the Benefice to which such portions shall be respectively annexed.

"5. That no alterations shall be made as to the Patronage and the endowment of any of the Benefices affected by this Scheme.

### UNIVERSITY OF CAMBRIDGE.

STATUTES TO ALTER AND AMEND THE STATUTES IN RELATION TO THE UNIVERSITY OF CAM-BRIDGE MADE UNDER "THE UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923" (13 & 14 GEORGE V., CHAPTER 33).

We, the Chancellor, Masters, and Scholars of the University of Cambridge in pursuance of the power given to us by the 7th Section of the Universities of Oxford and Cambridge Act, 1923, do hereby alter and amend the Statutes made under that Act in relation to our said University in manner following, that is to say:—

## STATUTE A.

THE CHANCELLOR AND THE GOVERNMENT OF THE UNIVERSITY.

### CHAPTER III.

#### THE REGENT HOUSE.

By inserting in Section 3 the following additional paragraph :---

"(f) Holders of posts recognized by Ordinance for this purpose in institutions forming part of or connected with the University."

### CHAPTER IV.

## THE COUNCIL OF THE SENATE.

By repealing Section 4 of Chapter IV and<sup>i</sup> substituting therefor the following amended Section':---

"4. If any member of the Council, other than the Chancellor or the Vice-Chancellor, is absent from all the meetings of the Council in any term, the Council may by a resolution carried not later than the last meeting of that term by a majority of the whole Council approve the cause of his absence.
