RULES PUBLICATION ACT, 1893.

The Minister of Agriculture and Fisheries hereby gives notice that in exercise of the powers conferred upon him under the Land Drainage Act, 1930, he proposes to make statutory rules with the approval of the Treasury for the purpose of prescribing the conditions under which contributions may be made by him towards expenses incurred by Catchment Boards in the improvement of existing works or the construction of new works.
