" 5. That the Incumbent of the Parish to which such portion of Parishes as aforesaid shall be respectively annexed under the provisions of this Scheme shall have the exclusive charge of Souls within the limits of such portions.

" 6. That the fees for Marriages, Churchings and Burials and other Ecclesiastical dues, offerings and emoluments received from the said portions so transferred shall henceforth belong to the Incumbent of the Benefice to which such portions shall be respectively annexed.

" 7. That no alterations shall be made as to the Patronage or the endowment of any of the Benefices affected by this Scheme.
