- "5. In the same County and Diocese is the Vicarage of St. Barnabas Mitcham the Parish whereof lies adjacent to the said Ecclesiastical Parishes of Tooting Graveney, Christ Church, Mitcham and St. Mark Mitcham and contains according to the census of One thousand nine hundred and twenty-one a population of four thousand eight hundred and thirty-nine and the net annual value thereof is four hundred pounds:
- "6. The southernmost portions of the said Ecclesiastical Parish of Tooting Graveney lie to the south of the Tooting Merton and Wimbledon Branch of the Southern Railway and at a distance from the Parish Church of Tooting Graveney and adjacent to the said Ecclesiastical Parishes of Christ Mitcham and St. Barnabas Mitcham:
- "7. The western portion of the said Ecclesiastical Parish of Tooting Graveney lies at a distance from the Parish Church of Tooting Graveney and adjacent to the said Ecclesiastical Parish of St. Mary Summerstown:
- "8. The northernmost portions of the Ecclesiastical Parish of Christ Church Mitcham lie to the north of the said Railway Church mentioned in clause 6 hereof and at a distance from the Parish Church of Christ Church Mitcham and adjacant to the said Ecclesiastical Parish of Tooting Graveney:
- "9. The eastern portion of the said Ecclesiastical Parish of Christ Church, Mitcham lies at a distance from the Parish Church of Christ Church, Mitcham and adjacent to the said Ecclesiastical Parish of St. Barnabas, Mitcham:
- "10. The north eastern corner of the said Ecclesiastical Parish of St. Mark, Mitcham lies at a distance from the Parish Church of St. Mark, Mitcham and adjacent to the said Ecclesiastical Parish \mathbf{of} St. Barnabas, Mitcham:
- "11. It appears to me that the following alterations in the boundaries of the said respective Parishes may be made with advantage to the interests of religion videlicit:—(a) the western portion of the said Ecclesiastical Parish of Tooting Graveney be united to the Ecclesiastical Parish of St. Mary Summerstown; (b) the southern portion of the said Ecclesiastical Parish of Tooting Graveney to the south of the said Railway which comprises (inter alia) the Tooting and Merton Brick works and also that triangular portion of the said Ecclesiastical Parish of Tooting Graveney which lies between the two branches of the said Railway at Tooting Junction be united to the Ecclesiastical Parish of Christ Church Mitcham; (c) the triangular portion of the said Ecclesiastical Parish of Tooting Graveney which lies to the immediate south of the lastly hereinbefore mentioned triangular portion of the said Parish be united to the said Ecclesiastical Parish of St. Barnabas Mitcham;

- "12. The Reverend Derek Harold Ellice Keppel is the present Incumbent of the said Benefice of Tooting Graveney and Sir Charles King Harman, K.C.M.G., of Ouse Manor, Sharnbrook, in the County of Bedford, is the Patron thereof:
- "13. The Reverend William Galpin is the present Incumbent of the said Benefice of St. Mary Summerstown and the Right Honourable William, Viscount Brentford, the Right Reverend James Theodore Inskip, Lord Bishop of Barking, Thomas Walter Gilbert, of St. John's College, Highbury, in the County of London, Clerk in Holy Orders, the Honourable William Talbot Rice of St. Paul's Vicarage, Onslow Square, in the said County of London, Clerk in Holy Orders, and Sir Arthur Grey Hazlerigg of Noseley Hall, in the County of Leicester, Baronet, are the Patrons thereof:
- " 14. The Reverend Douglas Matthews is the present Incumbent of the said Benefice of Christ Church Mitcham and I, the said Bishop of Southwark, in right of my said Bishopric, am the Patron thereof:
- "15. The Reverend Edward John Baker is the present Incumbent of the said Benefice of St. Barnabas, Mitcham, and Francis Richard Dale, D.S.O., M.C., M.A., Headmaster of The City of London School, Sir John Lulham Pound of 'Fairlight' 12 Shepherds Hill, Highgate, in the County of Middlesex, Baronet, J.P., and Joseph Sutton Withers of 51, Chancery Lane, in the County of London, Esquire, with myself the said Bishop of Southwark are the Patrons thereof:
- " 16. The \mathbf{W} illiam Reverend Kendrick Roberts is the present Incumbent of the said Benefice of St. Mark Mitcham and I, the said Bishop of Southwark, in right of my said Bishopric, am the Patron thereof:
