WHEREAS it is provided by the London Naval Treaty Act, 1930, (hereinafter referred to as the Act), that Section I of the Act shall come into force on such day as may be fixed by Order of His Majesty in Council:

 $\mathbf{W}^{\text{HEREAS}}$ the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 26th day 65-33698

of February, 1931, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for altering the boundaries of the Parishes of the Benefices of Brabourne with Monks Horton, Smeeth, and Sellindge, all of which Benefices are situate in the County of Kent and in the Diocese of **Canterbury**:

"Whereas Commissioners appointed at our request by the Right Reverend Cosmo Gordon, Archbishop of Canterbury, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report (inter alia) upon the rearrangement of the said Benefices of Brabourne with Monks Horton, Smeeth, and Sellindge, duly made their Report to the said Archbishop of Canterbury and therein recommended certain alterations of the boundaries of the Parishes of the said Benefices of Brabourne with Monks Horton, Smeeth, and Sellindge, and the said Archbishop of Canterbury signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said alterations of boundaries, which said Scheme, based upon the terms recommended in the said Report, but with the assent of the said Archbishop of
