House of Commons are not precluded from tendering for these Bills.

THE DANGEROUS DRUGS REGULATIONS, 1931, DATED APRIL 15, 1931, MADE BY THE SECRETARY OF STATE UNDER SECTION 7 OF THE DANGEROUS DRUGS ACT, 1920 (10 & 11 GEO. 5. C. 46) FOR CONTROLLING THE MANUFACTURE, SALE, POSSES-SION AND DISTRIBUTION OF DANGEROUS DRUGS TO WHICH PART III OF THAT ACT APPLIES.

In pursuance of Section 7 of the Dangerous Drugs Act, 1920, I hereby make the following Regulations amending the Dangerous Drugs (Consolidation) Regulations, 1928,(a) made under that Section on the 14th December, 1928, hereinafter referred to as the Principal Regulations:—

1. Nothing in the Principal Regulations shall apply to the preparations mentioned in the Schedule to these Regulations, and those preparations shall be added to the Third Schedule to the Principal Regulations.

2. Copies of the Dangerous Drugs (Consolidation) Regulations, 1928, printed under the authority of His Majesty's Stationery Office may be printed with the addition directed to be made by these Regulations.

3. These Regulations may be cited as the Dangerous Drugs (Consolidation) Amendment Regulations, 1931.

APPOINTMENT OF A STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DISTRICT, AND REGULATIONS TO BE OBSERVED.

> By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, the undersigned, Acting Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Hackney Carriages at the following place, and do make the following Regulations with regard to the Boundaries for the same, viz.:--

16th March, 1931.	APPOINTMENT.
At Approach Road, Raynes Park.	Three Hackney Carriages: On North side of roadway, commencing at a point fifteen yards East of junction with Grand Drive and extending Eastward, by kerb, as far as necessary for three carriages. Front of vehicles toward the West.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
