#### DANGEROUS DRUGS ACTS, 1920-1925.

##### WITHDRAWAL OF AUTHORITY.

(WILFRED ALAN BENSON.)

Whereas Wilfred Alan Benson, L.R.C.P.I., L.R.C.S.I., of 2, Mount Pleasant, Bury New Road, Manchester, has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said Wilfred Alan Benson cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Wilfred Alan Benson the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and to supply raw opium, coca leaves and Indian hemp and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that it shall not be lawful for the said Wilfred Alan Benson to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in the Artificial Silk Warping and Winding Department at the works of Messrs. Carrington and Dewhurst Limited, Grove Mills, Ecclestone, near Chorley, Lancashire, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.

#### GAS UNDERTAKINGS ACTS, 1920 AND 1929.

Notice by the Board of Trade regarding application by the Reigate Corporation for an Amending Order under Sub-section (3) of Section I of the Gas Regulation Act, 1920, in respect of the East Surrey Gas Company.

The Board of Trade hereby given notice that the Reigate Corporation, having made application under Sub-section (3) of Section I of the above-named Act for an Amending Order revising the powers of charging authorized by the Redhill Gas (Charges) Order, 1921, the Board propose to authorise new standard prices of 14d. per therm and 15.2d. per therm in lieu of the existing standard prices of 16.8d. per therm and 18d. per therm respectively.
