At the Court at Buckingham Palace, the 19th day of May, 1931.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 30th day of April, 1931, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Section VI of Schedule V to Your Order in Council bearing date the 22nd day of January, 1920, to sanction, inter alia, the payment of various allowances under specified conditions:

"And whereas we consider that the rules governing the payment of Navigating Allowance, Surveying pay and the Allowance to Non-specialists for performing Specialist duties require revision in certain respects:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the proposals contained in the Schedule annexed hereto, with retrospective effect to the 18th August, 1930.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

" SCHEDULE.

- "(1) Lieutenant Commanders and Lieutenants (other than those promoted from warrant rank) qualified as (N) Specialists, when appointed to a Surveying Ship for training in surveying duties, but not specifically for navigating duties, to be given the option of drawing either surveying pay at the appropriate rate, or (N) allowance, whichever is the greater, but not both.
- "(2) A non-specialist officer actually performing navigating duties in a Surveying Ship in the complement of which an (N) specialist is allowed but not borne specifically for (N) duties, to be paid non-specialist allowance of 1s. a day, if the officer is within the ranks ordinarily eligible for that allowance, notwithstanding that (N) specialists are borne in the ship for training as in rule (1) above."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with

the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Trelystan, in the County of Montgomery and in the Diocese of Hereford:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Trelystan is vested in John Murray Naylor, of Leighton Hall, Welshpool, in the said -County of Montgomery, Esquire, as tenant for life free from incumbrances and the said John Murray Naylor is therefore the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said John Murray Naylor is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Trelystan should be transferred to and be vested in the Bishop of Hereford for the time being:

"And whereas the Right Reverend Lisle, now Bishop of Hereford, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Lisle, Bishop of Hereford, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Trelystan which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Trelystan:

"Now, therefore, with the consent of the said John Murray Naylor, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony of which consent he has signed and sealed this Scheme) and with the consent of the said Lisle, Bishop of Hereford (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Trelystan shall be transferred to the said Lisle, Bishop of Hereford, and his successors in the same Bîshopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Lisle, Bishop of Hereford, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Hereford.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 29th day

of January, 1931, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being an United Benefice) of Alvingham with North Cockerington and the Benefice (being a Vicarage) of South Cockerington, both of which Benefices are situate in the County of Lincoln and in the Diocese of Lincoln:

"Whereas Commissioners appointed at our request by the Right Reverend William Shuckburgh, Bishop of Lincoln, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Alvingham with North Cockerington and South Cockerington duly made their Report to the said Bishop of Lincoln and therein recommended the union of the said two Benefices and the terms for effecting the union including an alteration of boundaries affecting the Parishes of the said Benefices of Alvingham with North Cockerington and South Cockerington and the Parish of Saltfleetby, Saint Peter, being one of the Parishes of the United Benefice of Saltfleetby, All Saints, with Saltfleetby, Saint Peter, situate in the said County and Diocese, and the said Bishop of Lincoln signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union of Benefices based upon the terms recommended in the said Report:

"And whereas the said Benefice of South Cockerington is now full, the Reverend Arthur Ronald Handyside being the present Incumbent thereof and the said Benefice of Alvingham with North Cockerington is at present vacant:

"And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said two Benefices of Alvingham with North Cockerington and South Cockerington now belongs to one and the same Patron:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said William Shuckburgh, Bishop of Lincoln (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Alvingham with North Cockerington and the said Benefice of South Cockerington shall be permanently united together and form one Benefice with cure of souls under the style of 'The United Benefice of Alvingham with North and South Cockerington' but the parishes of the said Benefices shall continue distinct in all respects.

"2. That if upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette both of the said two Benefices shall be vacant the union of the same two Benefices shall take effect forthwith, and if the said

Benefice of South Cockerington only shall be then vacant the said union shall also take effect forthwith if the Incumbent of the other of the said two Benefices shall consent to become the first Incumbent of the United Benefice but if he shall not so consent, then the said union shall take effect upon the then next avoidance of the said Benefice of Alvingham with North Cockerington and the then Incumbent of South Cockerington shall be the first Incumbent of the United Benefice, and if the said Benefice of Alvingham with North Cockerington only shall be then vacant the said union shall take effect upon the next avoidance of the said Benefice of South Cockerington and if neither of the said two Benefices be then vacant, the said union shall take on the next avoidance of the Benefice of South Cockerington if Incumbent at that time of the said Benefice of Alvingham with North Cockerington shall have been instituted to Alvingham with North Cockerington subsequently to the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or if instituted before that date shall consent to become the Incumbent of the United Benefice, but if he shall have been instituted to the said Benefice of Alvingham with North Cockerington before that date and shall not so consent, then the said union shall take effect immediately upon the next vacancy of the said Benefice of Alvingham with North Cockerington following such avoidance of the said Benefice of South Cockerington and the then Incumbent of the said Benefice of South Cockerington shall become the first Incumbent of the United Benefice.

"3. That at any time and from time to time after the union has taken effect the Incumbent of the United Benefice shall employ such clerical or lay assistance in the performance of the duties of the United Benefice as the Bishop may require and towards the remuneration of clergy or lay workers so required to be employed the Incumbent of the United Benefice shall be liable to provide out of the income of the United Benefice such sum as may be necessary not exceeding the sum of £30 in any one year.

"4. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Alvingham with North Cockerington shall become and be the house of residence for the Incumbent of the United Benefice.

"5. That with the consents of the alternate Patrons of the said United Benefice of Saltfleetby, All Saints, with Saltfleetby, Saint Peter, namely the President and Scholars of the College of Saint Mary Magdalen in the University of Oxford and the Provost and Scholars of the House of the Blessed Mary the Virgin in Oxford commonly called Oriel College of the Foundation of Edward the Second of Famous Memory sometime King of England (in testimony of which consents they have respectively caused their Common or Corporate Seals to be affixed to this Scheme) upon the union taking effect or upon the vacation of the said United Benefice of Saltfleetby, All Saints with Saltfleetby, Saint Peter, by the Reverend William Jackson Palmer now Incumbent thereof (whichever shall the later happen) all those detached portions of the said Parishes of North Cockerington and South Cockerington which are situate within the area of the Civil Parish of South Cockerington and lie to the east and north east of the main portion of the said Parish of South Cockerington shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Saltfleetby, Saint Peter.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas certain objections have been so stated or transmitted to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Lincoln has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lincoln.

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting certain alterations of the boundaries of the Parishes of the Benefices of Charleton, Loddiswell, Woodleigh, Churchstow with Kingsbridge and Moreleigh, all of which Parishes are situate in the County of Devon and in the Diocese of Exeter:

"Whereas Commissioners appointed at our request by the Right Reverend William, Bishop of Exeter, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the rearrangement of the said Benefices of Charleton, Loddiswell and Woodleigh duly made their Report to the said Bishop of Exeter and therein recommended certain alterations of the boundaries of the Parishes of the said Benefices of Charleton, Loddiswell and Woodleigh and also of the Parish of Churchstow (being one of the Parishes of the said Benefice of Churchstow with Kingsbridge) and of the Parish of the said Benefice of Moreleigh and the said Bishop of Exeter signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for effecting the alterations of boundaries so recommended which Scheme is based upon the terms recommended in the said Report:

"And whereas all of the said Benefices of Charleton, Loddiswell, Woodleigh, Churchstow with Kingsbridge, and Moreleigh are now full, the Reverend Prebendary Vincent Young being the present Incumbent of the said Benefice of Charleton, the Reverend Herbert Francis Gane being the present Incumbent of the said Benefice of Loddiswell, the Reverend Arthur Seymour being the present Incumbent of the said Benefice of Woodleigh, the Reverend George Edmund John Porter being the present Incumbent of the said Benefice of Churchstow with Kingsbridge and the Reverend William Swatridge being the present Incumbent of the said Benefice of Moreleigh.

"Now, therefore, with the consent of the said William, Bishop of Exeter, as such Bishop and also as the Patron in right of his Bishopric of the said Benefices of Churchstow with Kingsbridge and Moreleigh (in testimony whereof he has signed this Scheme), and with the consents of the following Incumbents affected namely the said Herbert Francis Gane, Arthur Seymour, George Edmund John Porter and William Swatridge (testified by their respectively signing this Scheme), we, the said

Ecclesiastical Commissioners for England, do humbly recommend and propose to Your Majesty as follows, that is to say:—

- "1. That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme:—(a) All that detached part of the said Parish of Moreleigh which lies within the area of the Civil Parish of Woodleigh shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Woodleigh; and (b) all that part of the said Parish of Loddiswell which lies to the south of the middle of the River Avon shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Churchstow and to the said Benefice of Churchstow with Kingsbridge.
- "2. That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme or upon the vacation of the said Benefice of Charleton by the said Vincent Young (whichever shall the later happen) all that part of the said Parish of Loddiswell which is comprised within the area of the Civil Parish of Buckland Tout Saints shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Charleton.
- "Provided always that no alteration in the endowments or patronage of any of the Benefices affected shall be made by reason of the said alterations of boundaries.

"And provided further that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Exeter has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Exeter.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, duly prepared, and laid before His Majesty in Council a Scheme, bearing date the 26th day of February, 1931, in the words and figures following, that is to say:—

- "We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 3rth and 38th years of Her said late Majesty, Chapter 63, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme with respect to some of the Rural Deaneries within the Archdeaconry of Hastings and the Archdeaconry of Lewes, both in the Diocese of Chichester:
- . "Whereas it has been represented to us by the Right Reverend George Kennedy Allen, Bishop of Chichester, that the arrangements which are hereinafter recommended and proposed with respect to some of the Rural Deaneries within the said Archdeaconries of Hastings and Lewes are desirable and should be carried into effect, and we are of opinion that the same may be properly carried into effect:
- "Now, therefore, with the consent of the said George Kennedy Allen, Bishop of Chichester (in testimony whereof he has set his hand and Episcopal Seal to this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, and without any assurance in the law other than such duly gazetted Order, first, a new Rural Deanery shall be formed within the said Archdeaconry of Hastings, and such new Rural Deanery shall be called 'The Rural Deanery of Battle and Bexhill' and shall comprise and consist of the Parishes or Cures of Battle; Bexhill; Bexhill, Saint Barnabas; Bexhill, Saint Mark; Bexhill, Saint Stephen; Sidley, All Saints; Catsfield; Crowhurst; Hooe; Netherfield; Ninfield and Sedlescombe with Whatlington, all at present in the Rural Deanery of Hastings, in the said Archdeaconry of

Hastings; and secondly, the Parish of Barcombe shall be transferred from the Rural Deanery of Uckfield, in the said Archdeaconry of Lewes, to the Rural Deanery of Lewes, in the same Archdeaconry, and each of the Parishes or Cures hereinbefore referred to shall be subject to the jurisdiction and authority of the Rural Dean of the Rural Deanery and of the Archdeacon of the Archdeaconry to which it is hereby transferred, and shall not belong to or be a part of any other Rural Deanery or Archdeaconry, nor be subject to the jurisdiction and authority of any other Rural Dean or of any other Archdeacon.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other matter or thing with respect to the matters aforesaid, or any of them, by virtue of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas notices of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Archdeacons affected by the Scheme, that is to say, to the Archdeacon of Hastings and to the Archdeacon of Lewes, and they have severally expressed their approval of the same:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chichester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 12th day of March, 1931, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and

3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Katharine, Bishopston, situate in the New Parish (sometime Consolidated Chapelry) of Saint Michael and All Angels, Bishopston, in the County of Gloucester and in the Diocese of Bristol:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Katharine, Bishopston, situate as aforesaid:

There shall be transferred and annexed to the said Benefice of Easton, Saint Paul, as part of the endowments thereof: (a) the yearly sum or stipend of £60 per annum now payable by us, the said Ecclesiastical Commissioners, to the Incumbent of the said Benefice of Wells (Saint Cuthbert) in respect of the employment of a Curate within the Hamlet of Wookey Hole in the said Parish of Wells (Saint Cuthbert); (b) all that capital sum of £100 being

"6. That upon the union taking effect all the Tithe Rentcharges Glebe lands and all other the endowments belonging to the said

United Benefice or which may hereafter belong to the same United Benefice shall be charged and for ever after be chargeable in favour of the Incumbents for the time being of the two under mentioned Benefices namely the said Benefice of Talbot Village, Saint Mark, and the Benefice of Edington, in the said Diocese of Salisbury, with the annual sums or yearly rentcharges hereinafter mentioned that is to say (1) a clear annual sum or yearly rentcharge of £85 in favour of the Incumbent for the time being of the said Benefice of Talbot Village, Saint Mark, and (2) a clear annual sum or yearly rentcharge of £50 in favour of the Incumbent for the time being of the said Benefice of Edington; the same annual sums or yearly rentcharges to be as from the date of the said union taking effect due and payable to the Incumbents of the said Benefices of Talbot Village, Saint Mark, and Edington respectively, and the said annual sums or yearly rentcharges to be apportionable in each case between any outgoing Incumbent of either of the said Benefices of Talbot Village, Saint Mark, and Edington or his representatives on the one hand and his successor in the same Incumbency on the other hand and to be receivable by the Incumbents in whose favour they are charged as aforesaid by equal half yearly payments on the first day of May and the first day of November in every year and for the recovery of the said yearly rentcharges in each case the Incumbents of the said Benefices of Talbot Village, Saint Mark, and Edington, and their successors shall have and be entitled to all the powers and remedies provided by Sections 121 and 122 of the Law of Property Act, 1925, in respect of rent-charges to which those Sections apply. Provided always that if at any time the Incumbent for the time being of the said United Benefice shall by any deed duly executed by him under his hand and seal in accordance with the provisions of any statute in that behalf enabling him, grant, convey and annex to the said Benefices of Talbot Village, Saint Mark, and Edington, or either of them, any part or parts of the endowments belonging to the said United Benefice which shall in the opinion of the Bishop of Salisbury for the time being be a just and fair equivalent or not less than an equivalent for both or either of the said yearly rentcharges hereby proposed to be created as aforesaid then in each case in which such equivalent provision shall have been made the corresponding annual sum or yearly rentcharge shall thereupon and thenceforth cease and be no longer payable.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure and Acts, or of any other Measure of the National Assembly of the Church of England, or Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time

And whereas certain objections have been so stated or transmitted to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Salisbury has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure and Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.

"And whereas by the authority of an Order of Your Majesty in Council bearing date the 17th day of July, 1917, and published in the London Gazette on the same day, a District Chapelry was assigned to the consecrated Church of Saint John the Baptist, Knighton, situate in the New Parish of Saint Mary Magdalen, Knighton, in the said County of Leicester and at that time in the said Diocese of Peterborough, but now in the said Diocese of Leicester, and the said District Chapelry was named 'the District Chapelry of Saint John the Baptist, Knighton':

"Whereas we are satisfied that the said New Parish of Christ Church, Eccleston, is a Cure wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said New Parish of Christ Church, Eccleston, which is hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas there has been contributed and paid a capital sum of £5,000 towards the cost of erecting a permanent Church within and for the said proposed separate District:

"And whereas the said capital sum of £5,000 has been contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District, and when such District shall have become a New Parish, then of the said New Parish, and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

"And whereas the contributors of the said capital sum of £5,000 towards the cost of erecting such permanent Church have nominated to us the right Reverend Albert Augustus, Bishop of Liverpool, the Venerable George John Howson, Clerk in Holy Orders and Archdeacon of Warrington, William Norman Pilkington, of Rainford Hall, Saint Helens, in the said County of Lancaster, Esquire, Albert Fred Mann, of Mayfield, Central Avenue, Eccleston Park, in the said County of Lancaster, Esquire, and Harry Platt, of Number 164, Rivington Road, Saint Helens, aforesaid, Esquire, as the persons to whom they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

"Now, therefore, with the consent of the said Albert Augustus, Bishop of Liverpool (in testimony whereof he has signed and sealed this Scheme), we the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said New Parish of Christ Church, Eccleston, which is described in the Schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual purposes and that the same shall be named 'The District of Saint Luke, Eccleston.

"And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid, then of such New Parish and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to and be absolutely vested in the said Albert Augustus, Bishop of Liverpool, George John Howson, William Norman Pilkington, Albert Fred Mann and Harry Platt to be held by them as trustees in fee simple upon the trusts declared by a certain Indenture already prepared and intended to be executed by the said Albert Augustus, Bishop of Liverpool, George John Howson, William Norman Pilkington, Albert Fred Mann and Harry Platt.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Luke, Eccleston, being:-

And whereas notwithstanding such objections the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

WYHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council a Scheme bearing date the 29th day of January, 1931, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Vicarage) of Shoreditch, Saint Michael, and the Benefice (being a Vicarage) of Curtain Road, Saint James, both of which Benefices are situate in the County of Middlesex and in the Diocese of London:

"Whereas Commissioners appointed at our request by the Right Reverend Arthur Foley, Bishop of London, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report (inter alia) upon the union of the said two Benefices of Shoreditch, Saint Michael, and Curtain Road, Saint James, duly made their Report to the said Bishop of London and therein recommended the union of the said two Benefices and the terms for effecting the union, including an alteration of boundaries affecting the Parish of the United Benefice hereinafter recommended and proposed to be constituted and the Parish of the Benefice of Shoreditch, Saint Leonard, in the said County of Middlesex and in the said Diocese of London, and the said Bishop of London signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union of Benefices based upon the terms recommended in the said Report:

"And whereas both of the said Benefices of Shoreditch, Saint Michael, and Curtain Road, Saint James, are now full, the Reverend George Paget Ford being the present Incumbent of the said Benefice of Shoreditch, Saint Michael, and the Reverend Herbert James Salmon being the present Incumbent of the said Benefice of Curtain Road, Saint James, and the said Benefice of Shoreditch, Saint Leonard, is also full, the Reverend William James Simmons being the present Incumbent thereof:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Arthur Foley, Bishop of London (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Shoreditch, Saint Michael, and the said Benefice of Curtain Road, Saint James, shall be permanently united together and form one Benefice with cure of souls under the style of 'The Benefice of Shoreditch, Saint Michael' (hereinafter called the United Benefice) and that the

Parishes of the said Benefices shall also be united into one Parish for ecclesiastical purposes and for such other purposes as in the

said Measure provided.

"2 That the Church of the Parish of Shoreditch, Saint Michael, shall be the Parish Church of the United Parish and that the Table of Fees for the said Parish of Shoreditch, Saint Michael, shall (until revised or altered by proper authority) be the Table of Fees for the United Parish.

"3. That with the consent of the said George Paget Ford (testified by his signing this Scheme), if upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the said Benefice of Curtain Road, Saint James, shall be vacant, the union shall take effect forthwith; but if the said Benefice of Curtain Road, Saint James, shall not be then vacant the said union shall take effect upon the next avoidance thereafter of the said Benefice of Curtain Road, Saint James, and in either case the said George Paget Ford, if he is then Incumbent of the said Benefice of Shoreditch, Saint Michael, shall become the first Incumbent of the United Benefice.

"4. That upon the union taking effect the register books of baptisms, marriages and burials and other the records and muniments deposited in the Church of Curtain Road, Saint James, shall be transferred to the Church of Shoreditch, Saint Michael, but the marriage registers in duplicate current at the Church of Curtain Road, Saint James, shall first be sent by the Incumbent of the United Benefice to the Registrar General to be closed officially.

"5. That in the event of the services of the organist or any of the Church servants of the Church of Curtain Road, Saint James, being dispensed with by reason of the union taking effect, such organist or Church servants shall, out of any moneys to be received by us the said Ecclesiastical Commissioners under the provisions of Clause 11 of this Scheme, receive such reasonable compensation as having regard to age, length of office, and other circumstances of the case, shall seem to us and to the Bishop of London equitable and proper.

"6. That upon the union taking effect all the properties, revenues and income constituting the endowments of the said two Benefices of Shoreditch, Saint Michael, and Curtain Road, Saint James, respectively shall be transferred and annexed to the United Benefice, and out of the endowments of the United Benefice the Incumbent shall be entitled to retain an annual sum of £600 and the residue of such endowments shall be applied as hereinafter

recommended and proposed.

"7. That two Curates be appointed to assist the Incumbent in performing the duties of the United Benefice, one Curate particularly to serve the Mission Church of Saint Agatha, Shoreditch, situate in the Parish of the said Benefice of Shoreditch, Saint Michael, and to have a stipend of not less than £300 per annum and the other Curate to have a stipend of not less than £214 per annum, this recommendation and proposal being made to the intent that the Bishop shall have the power of requiring the appointment of two Curates in accordance with and subject to the conditions and provisions of Subsection (b) of

Section 18 of the said Union of Benefices Measure, 1923, and towards the remuneration of the Curate to be appointed particularly to serve the Mission Church of Saint Agatha, Shoreditch, as aforesaid the Incumbent of the United Benefice shall be liable to provide out of the income of the United Benefice a sum of £274 in every year.

"8. That upon the union taking effect the two grants of £120 per annum each at present payable by us the said Ecclesiastical Commissioners out of our Common Fund one to the Incumbent of the said Benefice of Shoreditch, Saint Michael, and the other to the Incumbent of the said Benefice of Curtain Road, Saint James, conditionally upon the employment in each case of a Curate shall become payable to the Incumbent of the United Benefice conditionally upon the employment of Curates as aforesaid, and out of the combined sum of £240 per annum so payable a part, namely, £26 per annum shall be payable in respect of the services of the Curate serving the Mission Church of Saint Agatha, Shoreditch, as aforesaid, and the balance of £214 per annum shall be payable in respect of the services of the other Curate.

"9. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Shoreditch, Saint Michael, shall become and be the house of residence for the Incumbent of the United Benefice and so soon as conveniently may be the Parsonage House at present belonging to the said Benefice of Curtain Road, Saint James, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient and that the net proceeds of such sale shall constitute and form part of the aggregate fund hereinafter mentioned.

"10. That after the said union has taken effect the Patronage of the United Benefice shall belong wholly to the Patron of the said Benefice of Shoreditch, Saint Michael.

"11. (a) That so soon as conveniently may be after the union has taken effect the Church of Curtain Road, Saint James, shall be taken down and the materials and site thereof, including the whole area (other than the site of the Parsonage House of the said Benefice of Curtain Road, Saint James) conveyed in or about the year 1838 to the late Church Building Commissioners as a site for such Church shall be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measure, 1923.

(b) That the net proceeds to arise from such sale or sales after the appropriation to the Expenses Fund of the Diocese of London under the said Measure of so much of such proceeds as may in our opinion be necessary to defray the expenses attendant upon the sale or sales, the taking down of the Church, the removal of monuments (if any) and all other expenses incidental to these matters shall together with the net proceeds of the proposed sale as aforesaid of the Parsonage

House at present belonging to the said Benefice of Curtain Road, Saint James, form one aggregate fund which shall be applied by us, the said Ecclesiastical Commissioners, as follows, that is to say, (i) that there shall be paid thereout the compensation or compensations mentioned in Clause 5 of this Scheme (ii) that in the event of the endowments of the United Benefice being insufficient to produce the annual sum of £600 to be retained by the Incumbent as recommended and proposed in Clause 6 of this Scheme together with the further annual sum of £274 to be provided by the Incumbent towards the remuneration of Curates as recommended and proposed in Clause 7 of this Scheme, a capital sum sufficient to produce an income of such amount as may in our opinion be necessary to raise to £874 per annum the income from the endowments of the United Benefice shall be set aside and held and invested by us, the said Ecclesiastical Commissioners, as an addition to the endowments of the United Benefice (iii) that in the event of the said Herbert James Salmon within a period of one year after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme resigning the said Benefice of Curtain Road, Saint James, in order that the said union may thereupon take effect, there shall be paid to him by way of compensation a capital sum of £50 and also there shall be reserved in our hands a capital sum the income from which shall be sufficient in our opinion to raise his income as Incumbent of any Benefice to which he may thereupon be appointed to the annual amount of £410 if the income of such Benefice shall be less than that annual amount and the income from the said capital sum so reserved shall be payable to him for so long as he shall continue to hold that Benefice and after the cessation of such payment the capital sum shall fall into the residue hereinafter mentioned of the said aggregate fund (iv) that such a sum as may be approved by us, the said Ecclesiastical Commissioners, after consultation with the Bishop of London shall be applied by us towards the cost of repairs to the Church of Shoreditch, Saint Michael, or towards the extinction of any debt which may have been incurred in connection with such repairs (v) that a sum sufficient to produce an income of £25 per annum shall be held and invested by us as a fund for the maintenance of the fabric of the Church of Shoreditch, Saint Michael, or at our option be transferred to any body capable of holding and willing to hold the same for such purpose (vi) that a capital sum of £600 shall be held and applied by us towards the cost of repairs to the said Mission Church of Saint Agatha, Shoreditch, (vii) that a capital sum of £1000 shall be held and applied by us (according to the recommendations of the London Diocesan Fund) towards the cost of the repair of Churches situate in East London, and (viii) that the residue of the said aggregate fund shall be held and accumulated by us as a fund for and towards the purchase of a suitable site for and the erection of a new Church (to be in the patronage of the Patron of the said Benefice of Curtain Road, Saint James), for a District to be selected by the Bishop of London as the District for which such Church shall be built and for and towards the endowment of such District and

the provision of a Parsonage House therefor and any ultimate residue after the provision of a site for and the erection of such Church and the endowment of the same and the provision of a Parsonage House as aforesaid shall be added to the said Expenses Fund of the Diocese of London. Provided that in all or any of these cases pending the completion of the said sale or sales we, the said Ecclesiastical Commissioners, shall be at liberty to advance the necessary sums or sum out of the said Expenses Fund and to repay to such Fund the amount of such advances or advance with interest out of the net proceeds of such sale or sales as aforesaid.

(e) That the font, communion table, sacramental plate, bells, organ and other furniture and fittings of the said Church of Curtain Road, Saint James, or such of them as the Bishop of London shall select, shall be transferred to the Parish Church of the United Benefice, and any articles not so transferred shall be appropriated by the Bishop of London for use in the proposed Church of the said District or be transferred to any other Church or Chapel or Churches or Chapels within the Diocese of London which the Bishop may select: provided always that any articles that shall not be so transferred or appropriated except the font, communion table and sacramental plate, may be sold and the proceeds shall be added to the fund arising from the sale of the site and materials of the said Church of Curtain Road, Saint James, as aforesaid.

"12. That with the consent of the Venerable Ernest Newton Sharpe, Archdeacon of London, and as such Archdeacon Patron of the said Benefice of Shoreditch, Saint Leonard (which consent is testified by his signing this Scheme) and with the consent of the said William James Simmons (testified by his signing this Scheme), upon the union taking effect all that part of the said Parish of Shoreditch, Saint Leonard, which lies to the south of the middle of Great Eastern Street and to the west of the middle of the North London Railway shall be transferred and annexed for all ecclesiastical purposes to the Parish of the United Benefice.

"Provided always that the provisions herein contained relating to the sale and disposal of the site of the Church of Curtain Road, Saint James, shall not take effect until the consents and approval which by the said Union of Benefices Measure, 1923, are made requisite to the sale under the powers conferred by that Measure of the site of any Church, shall be obtained to the sale and disposal hereby proposed of the said Church of Curtain Road, Saint James, and of the site thereof together with any ground annexed or belonging thereto and provided also that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Com-

missioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of London has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been laid before both Houses of Parliament for the space

of two calendar months:

And whereas the said Scheme has been ap-

proved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

- "Whereas Commissioners appointed at our request by the Right Reverend William, Bishop of Exeter, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said Benefice of South Pool with a part of the said Benefice of Stokenham duly made their Report to the said Bishop of Exeter, and therein recommended the union of the said Benefice of South Pool with a part of the said Benefice of Stokenham containing the Chapel of Ease at Chivelstone and the terms for effecting such union including the transfer of a detached part of the Parish of the said Benefice of Stokenham to the Parish of the said Benefice of South Pool and the said Bishop of Exeter signified in writing his approval of the said Report:
- "And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union which Scheme is based upon the terms recommended in the said Report:

And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Exeter has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid: And whereas no appeal has been proceeded with to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Exeter.

"Whereas Commissioners appointed at our request by the Right Reverend William Shuckburgh, Bishop of Lincoln, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Blyton and Pilham and the Extra Parochial Place called or known as Greenhill and Redhill in the same County and Diocese duly made their report to the said Bishop of Lincoln and therein recommended the union of the said two Benefices and the terms for effecting the union and also recommended an alteration of the boundaries of the Parish of the Benefice of East Stockwith in the same County and Diocese by the annexation thereto of the said Extra Parochial Place and the said Bishop of Lincoln signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union of Benefices and alteration of boundaries based upon the terms recommended in the said Report:

"And whereas both of the said Benefices of Blyton and Pilham are now full, the Reverend Edward Samuel Letts being the present Incumbent of the said Benefice of Blyton and the Reverend Benjamin Davies being the present Incumbent of the said Benefice of Pilham:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said William Shuckburgh, Bishop of Lincoln (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Blyton and the said Benefice of Pilham shall be permanently united together and form one Benefice with cure of souls under the style of 'The United Benefice of Blyton with Pilham' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lincoln.

SHORES OR BANKS OF THE SEA AT HORNSEA.

PROHIBITION OF REMOVAL OF MATERIALS.

Whereas the Board of Trade acting in pursuance of the Harbours Act, 1814, as amended by the Harbours Transfer Act, 1862, found it necessary for the protection of the Port of Kingston-upon-Hull to issue an Order dated the 6th day of September, 1869, prohibiting the taking or removing of any shingle or ballast from the shores or banks of the sea between the northernmost boundary of the Parish of Hornsea and a point two and a half statute miles North of Spurn Point.

And whereas the Urban District Council of Hornsea desiring to construct certain sea defence works at Hornsea and to remove for the purpose of the said sea defence works a quantity of 7,000 cubic yards or thereabouts of sand shingle or ballast from the shore between Hornsea Burton Road and New Road Hornsea such shore being part of the shores and banks within the limits specified in the said Order of the 6th day of September, 1869, the Board of Trade did by an Order dated the 13th day of July, 1929, revoke the said Order of the 6th day of September, 1869, so far only as that Order prohibited the taking or removing by the said Urban District Council their servants or workmen for the purposes of the said defence works of any sand shingle or ballast (not exceeding in all 7,000 cubic yards thereof) from the shore at Hornsea between Hornsea Burton Road and New Hornsea.

And whereas the said Urban District Council have now completed the construction of the said sea defence works at Hornsea and have removed for the purposes of the said sea. defence works the quantity of sand shingle or ballast required therefor.

Now therefore the Board of Trade do by this Order revoke the said Order of the 13th day of July, 1929, and declare the same to be void and of no effect and do further declare that in all respects the said Order of the 6th day of September, 1869, shall again be and remain in full force and operate as heretofore.
