PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS IN ALL AREAS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Retail Bespoke Tailoring Trade Board (England and Wales), HEREBY GIVE NOTICE that they PROPOSE TO VARY Minimum Rates of Wages for certain classes of Male and Female Workers in all Areas as set out in the Notices issued by the Trade Board dated 20th February, 1930.
