In the county of Carmarthen.

The petty sessional divisions of Llanboidy, and St. Clears; and the parish of Trelech-a'r-Bettws.

FOOT-AND-MOUTH DISEASE (INFECTED
AREAS) ORDER OF 1931 (No. 41).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Extension of Foot-and-Mouth Disease Infected Area.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 40) shall be read and have effect as if the Area described in the Schedule to this Order were included in and formed part of the Foot-and-Mouth Disease Infected Area described in the Schedule to that Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 41).

FOOT-AND-MOUTH DISEASE (INFECTED
AREAS) ORDER OF 1931 (No. 43).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Extension of the Bedfordshire, etc. Foot-and-Mouth Disease Infected Area.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 36) as amended by the Foot-and-Mouth Disease (Infected Areas) Orders of 1931 (Nos. 38 and 39) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 39).

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 43).
