**ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.**

(DATED 16TH SEPTEMBER, 1931.)

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 48).**

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Declaration of Foot-and-Mouth Disease Infected Areas.*

1. The Areas described in the First and Second Schedules to this Order are hereby declared to be Foot-and-Mouth Disease Infected Areas for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

*Commencement and Revocation of certain Orders.*

2. This Order shall come into operation on the twenty-first day of September, nineteen hundred and thirty-one, on which date the Orders described in the Third Schedule to this Order shall be and are hereby revoked.

*Short Title.*

3. This Order may be cited as the **FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 48)** and shall be read with the Order referred to in Article 1.

An area comprising:—

*In the county of Bedford.*

The borough of Bedford;  
The parishes of Colmworth, Roxton, Wilden, Ravensden, Clapham, Goldington, Renhold, Great Barford, Willington, Cople, Cardington, Eastcotts, Elstow, Kempston, Biddenham, Blunham and Moggerhanger.

**SECOND SCHEDULE.**

An area comprising:—

*In the county of Huntingdon.*

The parishes of Woolley, Barham, Easton, Stow, and Spaldwick; so much of the parish of Catworth as lies to the south of the Thrapston-Huntingdon main road and as also lies to the east of the road from the Catworth Guide Post to Kimbolton; so much of the parish of Leighton as lies to the south and east of a boundary made by the Leighton Hill road and the road between Leighton Bromswold and Barham Church which passes Top Lodge and The Castle; and so much of the parish of Ellington as lies to the north and west of the road from Grafham to Huntingdon which passes through Ellington village.
