PUBLIC HEALTH ACTS AMENDMENT ACT, 1907, AND
 THE PUBLIC HEALTH ACT, 1925.

BY an Order dated the fourth day of September, 1931, the Minister of Health has Declared that, on and after the twenty-eighth day of September, 1931, the following provisions of the above-mentioned Acts shall be in force in the Borough of Haslingden, namely:—
