ORDER FOR THE ALTERATION OF CORONERS' DISTRICTS.

Whereas by virtue of section 4 (1) of the Coroners (Amendment) Act, 1926, the right of the Right Hangurable John Duncan of the Right Honourable John Duncan Vaughan, Earl Cawdor, Lord of the several John Duncan and respective Seigniories Liberties Royalties Honors Manors Lordships Freechase and Freewarren and Commotts of Kidwelly Carnwallon and Iskennen in the County of Carmarthen, to appoint a Coroner ceased on the vacancy in the Office of Coroner for such Liberties Honors Manors Lordships Free-chase and Freewarren and Commotts which occurred in consequence of the death of the Franchise Coroner, Mr. John William Nicholas, of Brynteilo, Llandilo, on the 25th day of February, 1931, and for all purposes relating to Coroners the area in which the said Franchise Coroner had jurisdiction thereupon became merged in the County of Carmarthen:

And whereas the area in which the said Franchise Coroner had jurisdiction is defined in the Schedule hereto:

And whereas by section 4 (2) of the Coroners (Amendment) Act, 1926, where any area in which a Franchise Coroner had jurisdiction is merged in a County which is divided into Coroners' Districts any consequential alteration of the division of the County into Coroners' Districts shall be effected in manner provided by that Act:

And whereas the County of Carmarthen is divided into two Coroners' Districts, namely, the Eastern or Llandilo District and the

Western or St. Clears District:

And whereas the County Council for the Administrative County of Carmarthen deem it expedient to constitute the area defined in the Schedule hereto a separate Coroner's District of the County to be known as the Three Commotts District, and have submitted to the Secretary of State a draft Order giving effect to this recommendation:

Now therefore, I, the undersigned, one of His Majesty's Principal Secretaries of State, in pursuance of the power vested in me by section 12 of the Coroners (Amendment) Act,

1926, do hereby Order—
1. That the said County of Carmarthen shall henceforth include the following County Coroner's District, viz.:-

The Three Commotts District comprising the parishes of:-

Ammanford Urban, Bettws, Bury Port Urban, Cwmamman Urban, Kidwelly, Llanddarog, Llandebie, Llanarthney,

Llandefeilog, Part of Llandilofawr called Llandilo Iscennen, Llanedy, Llandilo fihangel-Aberbythich, Part of Llangathen, Llangendeirne, Llangennech, Llangunnor, Llanelly Rural, Llanelly Urban, Llannon, Pembrey, Pontyberem, St. Ishmael.

The boundaries of the above district are as follows:-

On the South, the sea; on the West and North, the river Towy; on the North East, an irregular line from a point on the Towy a mile farther north than Llandilo Bridge to (say) half a mile east of Brynamman Railway Station; on the South East, the county boundary.

2. That this Order may be cited as the County of Carmarthen Coroners' Districts Order, 1931.
