which the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 49) or any Order amending that Order for the time being applies, provided that no such licence shall be granted unless the owner of the swine shall sign and give to the Local Authority an undertaking in the form set out in the Schedule to this Order, and also provided that no such licence shall be deemed to authorise the movement of any animals out of the said area."

#### Short Title.

2. This Order may be cited as the Foot-and-Mouth Disease (Birmingham Pig Market) (Amendment) Order of 1931, and shall be read as one with the Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1931.
