# SITTINGBOURNE AND MILTON.

#### THE SCHEDULE.

For the purposes of the Anglo-Yugo-Slavian telephone service, Yugo-Slavia is divided into 3 Zones. Telephonic communication is at present restricted in Yugo-Slavia to the following towns:--
