The KING has been pleased, by Letters Patent under the Great Seal of the Realm, bearing date the 29th instant, to confer the dignity of a Baronet of the United Kingdom upon Sir William Phené Neal of Cherry Hinton in the County of Cambridge, Knight, Lord Mayor of the City of London, and the heirs male of his body lawfully begotten.

The KING has been pleased, by Letters Patent under the Great Seal of the Realm, bearing date the 30th ultimo, to grant to the Reverend Walter Robert Matthews, M.A., D.D., Professor of the Philosophy of Religion and Dean of King's College, London, and one of the Canons Theologian of Liverpool Cathedral, the Deanery of the Cathedral Church of Exeter, void by the death of the Very Reverend Henry Reginald Gamble, M.A., D.D.

The KING has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 2nd instant, to appoint Hugh Montague, Baron Trenchard, G.C.B., D.S.O., Marshal of the Royal Air Force, to be Commissioner of Police of the Metropolis.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts of women of 18 and young persons of 16 years of age and over to assist in the work of the Galvanizing Department at the Maritime Galvanizing Works of Messrs. T. W. Glaze and Company, Cradley Heath, Staffordshire, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks, and that suitable protective clothing, suitable cloakroom and messroom accommodation and washing facilities shall be provided.
