SHEFFIELD GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 and 1929.)

THE Sheffield Gas Company (hereinafter called "the Company") whose address is Commercial Street, Sheffield, are applying to the Board of Trade for a Special Order under the Gas Undertakings Acts, 1920 and 1929, for the following objects:—

1. To transfer to and vest in the Company the undertaking of the Elsecar Wentworth and Hoyland Gas Company (hereinafter referred to as "the Elsecar Company") including all lands, hereditaments, easements, works, buildings and other property of whatsoever kind of or belonging to or vested in the Elsecar Company, except such property or assets (if any) as may be stated in the Order and to confirm the purchase of the said undertaking by the Company in pursuance of the Heads of Agreement between the Company and the Elsecar Company dated the 22nd October, 1931, but excepting such assets (if any) as may be stated in the Order.

2. To prescribe the consideration to be paid by the Company to the Elsecar Company for such transfer and vesting and the date on which the said transfer and vesting shall take effect or be deemed to take effect.

3. To make provision with respect to the debts and liabilities of, and moneys due or accruing due to, the Elsecar Company and the recovery thereof, and all such other provisions as may be necessary or convenient for the purpose of enabling the said transfer and vesting to be carried into effect and to provide for the

winding-up and dissolution of the Elsecar Company.

4. To repeal the Elsecar Wentworth and Hoyland Gas Act, 1863, and the Elsecar Wentworth and Hoyland Gas (Charges) Order, 1929.

5. To extend the limits of supply of the Company to include:—

(i) the limits within which the Elsecar Company are now authorised to supply gas (hereinafter referred to as "the Elsecar limits") viz.:—

The whole of the urban district of Hoyland Nether.

The whole of the parish of Wentworth in the rural district of Rotherham.

The parish of Brampton Bierlow in the rural district of Rotherham except the portion thereof which lies to the north-east and north of the following boundary viz.:—A line commencing on the western boundary of the parish at Smithy Bridge and drawn thence in an easterly direction along the centre line of Smithy Bridge Lane to the central point of the four cross roads at the Counting Houses thence in a southerly direction along the centre line of Coaley Lane to its junction with Hooper Hall Lane and thence in an easterly direction along the centre line of Hooper Hall Lane to the eastern boundary of the parish in Packman Road, and

(ii) the following area (hereinafter referred to as "the Blacker Hill area") in part of which the Elsecar Company are now supplying gas, viz.:—

The portion of the urban district of Worsborough which lies within the following boundary, viz.:—A line commencing at the northernmost point of the urban district of Hoyland Nether and drawn thence in a north-easterly direction along the Barrow Colliery Railway to the foot-bridge crossing that railway at a distance of about 39 chains north-eastwards from the point of commencement and thence in an easterly direction in a straight line to a point in Wombwell Lane where the boundary of the urban district of Worsborough strikes that lane and thence along the last mentioned boundary in a southerly, south-easterly, south-westerly and north-westerly direction to the point of commencement.

and to extend and apply to the Elsecar limits and the Blacker Hill area the provisions of the Sheffield Gas (Consolidation) Act, 1929, and the Sheffield Gas Act, 1931 (hereinafter referred to as "the existing Acts") with such exceptions and modifications as may be defined in the Order.

6. To prohibit or restrict the Mayor, Aldermen and Burgesses of the County Borough of Rotherham (hereinafter referred to as "the Rotherham Corporation") from supplying gas or exercising any powers with respect to the supply of gas in any part of the said parish of Wentworth in which they had not laid down and provided mains for the supply of gas prior to the twenty-fifth day of November, 1931. To amend section 14 of the Rotherham Corporation Act, 1904, and any other enactment relating to supply of gas by the Rotherham Corporation in the said parish.
