NATIONAL HEALTH INSURANCE ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, to make Regulations in exercise of the powers conferred upon them by sub-section (2) of Section 70 of the National Health Insurance Act, 1924, to be entitled the National Health Insurance (Investment Account, Rate of Interest) Regulations, 1931.

And that on account of urgency the National Health Insurance Joint Committee, under Section 2 of the Rules Publication Act, 1893, made Regulations entitled the National Health Insurance (Investment Account, Rate of Interest) Regulations, 1931, to come into force immediately as provisional regulations, to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.
