1. To extend the area of supply under the Mid Southern District Utility Acts and Orders 1909 to 1931 by the inclusion therein of the following area (hereinafter called "the added area") that is to say:—

In the County of Southampton,

The Rural District of Alresford,

The parishes of Warnford and West Meon in the rural district of Droxford,

The parishes of Avington, Itchen Abbas, Martyr Worthy and Morestead in the rural district of Winchester and so much of the parishes of Chilcomb Without, Easton and Kings Worthy in the said rural district of Winchester as lies outside a radius of two miles from the City Cross Winchester.

In the County of Surrey,

So much of the parish of Compton in the rural district of Guildford as is not already included in the area of the Company for the supply of electricity, being so much of such parish as lies to the north of the main road from Peasemarsh through the village of Compton to Wanborough Common.

So much of the parish of Godalming rural in the said rural district of Guildford as is not already included in the area of the Company for the supply of electricity being so much of the said parish as lies to the south of a line commencing at the point where the union boundary intersects the Southern Railway (Portsmouth line) about half-a-mile due east of the village of Milford and running thence in a straight line due east to the union boundary near Munstead.

- 2. To fix and define the date or dates from which the extension of the said area of supply shall take effect and to make provision with regard to the revocation of the powers of any other undertakers in the added area or any part or parts thereof.
- 3. To authorise the Company to generate and supply electricity for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1928 within the added area.
- 4. To extend and make applicable to the added area all or some of the provisions contained in the Mid Southern District Utility Acts and Orders 1909 to 1931 or in any Special Order that may be made under the Electricity (Supply) Acts 1882 to 1928 before the making of the proposed Special Order and to apply such provisions to the undertaking to be authorised by the Order subject to such variations and exceptions as may be contained therein.
- 5. To make provision as to the maximum prices to be charged by the Company within the added area.
- 6. To authorise the Company to open and break up in the added area streets and parts of streets and railways which are not repairable by the local authority.

- 7. To authorise the Company to raise additional capital for their electricity undertaking by the creation and issue of ordinary or preference stock and by borrowing on mortgage or by the creation and issue of debenture stock or by any of those modes and to provide that any stock issued as preference stock or debenture stock may be issued as redeemable preference stock or redeemable debenture stock as the case may be and to make other provisions with respect thereto.
- 8. To confer upon the Company all or some of the powers of the Electricity (Supply) Acts 1882 to 1928 and the enactments incorporated therewith and to alter vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order and to confer all other rights and privileges necessary for carrying such objects into effect.
- 9. To incorporate and apply with or without modification all or some of the provisions of the Companies Clauses Consolidation Act 1845 and the Companies Clauses Act 1863.
