For the purpose of the application of the above differential rates of wages for overtime employment the Anglesey and Caernarvon Agricultural Wages Committee have by Order, dated 24th April, 1931, defined the following employment as the employment which is to be treated as overtime employment:----

(a) All employment in excess of 6 hours on a Saturday or on such other day (not being Sunday) in every week as may be agreed between the employer and the worker except such time as is spent in feeding and cleaning stock by the special classes of workers.

(b) In the case of workers of 15 years of age and over wholly or mainly employed as horsemen, cowmen, shepherds or hwsmyn (bailiffs) all employment in excess of 60 hours in any week (excluding all hours which are to be treated as hours of overtime employment).

(c) In the case of other male workers, all employment in excess of 50 hours in any week (excluding all hours which are to be treated as hours of overtime employment).
