

Honourable and Most Reverend Cosmo Gordon, Lord Archbishop of Canterbury, in the following terms:—

"I, Frank Theodore, Bishop of Winchester, in pursuance of the twenty-sixth section of the Pluralities Act, 1838, do hereby represent to Your Grace as follows:—

"There is in the County of Southampton and Diocese of Winchester the Vicarage or Benefice of Monk Sherborne with Pamber the Parish whereof contains a population (according to the 1921 Census) of one thousand three hundred and two or thereabouts with accommodation in the Parish Church for one hundred and fifty persons.

"The net annual value of the said Benefice of Monk Sherborne with Pamber is four hundred and eighty-one pounds or thereabouts.

"There is also in the same County and Diocese the Rectory or Benefice of Baughurst the Parish whereof contains a population (according to the 1921 Census) of four hundred and eighty-three or thereabouts with accommodation in the Parish Church for two hundred and fifty persons.

"The net annual value of the said Benefice of Baughurst is three hundred and eighty-five pounds or thereabouts.

"There is also in the same County and Diocese the Rectory or Benefice of Wolverton with Ewhurst the Parish whereof contains a population (according to the 1921 Census) of two hundred and four or thereabouts with accommodation in the Parish Church for one hundred persons.

"The net annual value of the said Benefice of Wolverton with Ewhurst is four hundred and forty-four pounds or thereabouts.

"There is also in the same County and Diocese the Vicarage or Benefice of Ramsdell the Parish whereof contains a population (according to the 1921 Census) of four hundred and twelve or thereabouts with accommodation in the Parish Church for one hundred and forty persons.

"The net annual value of the said Benefice of Ramsdell is three hundred and sixty-nine pounds or thereabouts.

"There is also in the same County and Diocese the Rectory or Benefice of Tadley the Parish whereof contains a population (according to the 1921 Census) of one thousand one hundred and ninety-three or thereabouts with accommodation in the Parish Church for one hundred and twenty persons.

"There is also in the same County and Diocese the Vicarage or Benefice of Wootton St. Lawrence the Parish whereof contains a population (according to the 1921 Census) of seven hundred and two or thereabouts with accommodation in the Parish Church for one hundred and twenty persons.

"The net annual value of the said Benefice of Wootton St. Lawrence is four hundred and ninety-three pounds or thereabouts.

"There is also in the same County and Diocese the Rectory or Benefice of Eastrop the Parish whereof contains a population (according to the 1921 Census) of three hundred and twenty-nine or thereabouts with accommodation in the Parish Church for two hundred persons.

"The net annual value of the said Benefice of Eastrop is three hundred and ninety-six pounds or thereabouts.

"There is also in the same County and Diocese the Vicarage or Benefice of Old Basing with Up Nately the Parish whereof contains a population (according to the 1921 Census) of one thousand three hundred and twenty-seven or thereabouts with accommodation in the Parish Church for four hundred and fifty persons.

"The net annual value of the said Benefice of Old Basing with Up Nately is six hundred and sixty pounds or thereabouts.

"There is also in the same County and Diocese the Vicarage or Benefice of Basingstoke the Parish whereof contains a population (according to the 1921 Census) of twelve thousand four hundred and fifteen or thereabouts with accommodation in the Parish Church for one thousand and one hundred persons.

"The net annual value of the said Benefice of Basingstoke is eight hundred and fifty pounds or thereabouts.

"There is also in the same County and Diocese the Rectory or Benefice of Sherborne St. John the Parish whereof contains a population (according to the 1921 Census) of seven hundred and thirty-six or thereabouts with accommodation in the Parish Church for two hundred and fifty persons.

"The net annual value of the said Benefice of Sherborne St. John is six hundred and nineteen pounds or thereabouts.

"That it appears to me and I do hereby represent to Your Grace that under the provisions of the said Pluralities Act, 1838:—

(1) Two detached portions of the Parish of Monk Sherborne with Pamber (the boundaries of which portions are delineated on the map attached to the annexed Scheme and thereon respectively verged red and green) may advantageously be separated from the Parish of Monk Sherborne with Pamber and the portion verged red be annexed to the Parish of Baughurst to which it is contiguous and the portion verged green be annexed to the Parish of Wolverton with Ewhurst to which it is contiguous.

(2) Five other detached portions of the Parish of Monk Sherborne with Pamber (the boundaries of which portions are delineated on the said map and thereon verged dark blue) may advantageously be separated from the Parish of Monk Sherborne with Pamber and be annexed to the Parish of Wootton St. Lawrence to which they are contiguous.

(3) Another detached portion of the Parish of Monk Sherborne with Pamber (the boundaries of which portion are delineated on the map attached to the said Scheme and partly verged violet partly verged yellow and partly verged light blue) may advantageously be separated from the Parish of Monk Sherborne with Pamber and that portion verged violet be annexed to the Parish of Basingstoke to which it is contiguous that portion verged yellow to the Parish of Sherborne St. John to which it is contiguous and that portion verged light blue to the Parish of Old Basing with Up Nately to which it is contiguous.

(4) A detached portion of the Parish of Eastrop (the boundaries of which portion are delineated on the said Map and thereon verged orange) may advantageously be
