separated from the Parish of Eastrop and be annexed to the Parish of Basingstoke to

which it is contiguous.

(5) Two detached portions of the Parish of Wolverton with Ewhurst (the boundaries of which portions are delineated on the said Map and thereon verged dark brown and purple) may advantageously be separated from the Parish of Wolverton with Ewhurst and the portion verged dark brown be annexed to the Parish of Ramsdell to which it is contiguous and the portion verged purple to the Parish of Baughurst to which it is contiguous.

(6) Two detached portions of the Parish of Tadley (the boundaries of which portions are delineated on the said Map and thereon verged black) may advantageously be separated from the Parish of Tadley and be annexed to the Parish of Baughurst to which

they are contiguous.

"Queen's College Oxford are the Patrons of the Benefice of Monk Sherborne with Pamber and the Reverend Edward John Bolus is the present Incumbent thereof.

"I, Frank Theodore Bishop of Winchester, am the Patron of the Benefices of Baughurst, Ramsdell, and Tadley and the Reverend William Sterndale Steggall, the Reverend William Thomas Tovani, and the Reverend William Latimer Oakden Ward are the respective Incumbents thereof.

"His Grace the Duke of Wellington is the Patron of the Benefice of Wolverton with Ewhurst and the Reverend Douglas Leonard Board is the present Incumbent thereof.

"The Dean and Chapter of Winchester are the Patrons of the Benefice of Wootton St. Lawrence and the Reverend Francis Burton Allen is the present Incumbent thereof.

"Richard Alan Shields is the Patron of the Benefice of Eastrop and the Reverend Robert Thompson is the present Incumbent thereof.

"Magdalen College Oxford are the Patrons of the Benefices of Old Basing with Up Nately, and Basingstoke, and the Reverend William Inskip Digby Shuttleworth Read and the Reverend Harry Wilson Boustead, D.D., are the respective Incumbents thereof.

"Charles Lennard Chute is the Patron of the Benefice of Sherborne St. John and the Reverend Rupert Bede Winser is the present Incumbent thereof.

"That pursuant to the directions contained in the twenty-sixth section of the Pluralities Act, 1838, I, the said Bishop have drawn up a Scheme in writing annexed to this Representation describing the mode in which it appears to me that the alterations above proposed may best be effected and how the changes consequent on such alterations in respect of Ecclesiastical dues rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested and I do hereby submit the same to Your Grace together with the Consents in writing of the Patrons of the said Benefices of Monk Sherborne with Pamber, Baughurst, Wolverton with Ewhurst. Eastrop, Ramsdell, Tadley, Wootton St. Eastrop, Ramsdell, Tadley, Wootton St. Lawrence, Old Basing with Up Nately, Basingstoke and Sherborne St. John and also the like Consents of the Incumbents of the said Benefices to the intent that if Your Grace shall on full consideration and enquiry be satisfied with such Scheme you may certify the same

and such Consents aforesaid to His Majesty in Council."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:—

## " SCHEME.

"It is proposed to separate from the Parish of Monk Sherborne with Pamber all those two detached portions of the Parish of Monk Sherborne with Pamber which are delineated on the map hereto annexed and thereon verged red and green and annex that portion verged red to the Parish of Baughurst to which it is contiguous and that portion verged green to the Parish of Wolverton with Ewhurst to which it is contiguous.

"It is also proposed to separate from the said Parish of Monk Sherborne with Pamber and annex to the Parish of Wootton St. Lawrence all those five detached portions of the Parish of Monk Sherborne with Pamber which are delineated on the map hereto annexed and

thereon verged dark blue.

"It is also proposed to separate from the said Parish of Monk Sherborne with Pamber all that detached portion of the Parish of Monk Sherborne with Pamber which is delineated on the map hereto annexed and thereon verged violet, yellow, and light blue and annex that portion verged violet to the Parish of Basingstoke to which it is contiguous that portion verged yellow to the Parish of Sherborne St. John to which it is contiguous and that portion verged light blue to the Parish of Old Basing with Up Nately to which it is contiguous.

"It is also proposed to separate from the Parish of Eastrop and annex to the Parish of Basingstoke all that detached portion of the Parish of Eastrop which is delineated on the map hereto annexed and thereon verged orange.

"It is also proposed to separate from the Parish of Wolverton with Ewhurst all those two detached portions of the Parish of Wolverton with Ewhurst which are delineated on the map hereto annexed and thereon verged dark brown and purple and annex that portion verged dark brown to the Parish of Ramsdell to which it is contiguous and that portion verged purple to the Parish of Baughurst to which it is contiguous.

"It is also proposed to separate from the Parish of Tadley and annex to the Parish of Baughurst all those two detached portions of the Parish of Tadley which are delineated on the map hereto annexed and thereon verged

black.

"That the Incumbents of Baughurst, Wolverton with Ewhurst, Ramsdell, Wootton St. Lawrence, Basingstoke, Sherborne St. John and Old Basing with Up Nately shall have sole and exclusive cure of souls within those portions of the Parishes so to be separated from the Parishes of Monk Sherborne with Pamber, Old Basing with Up Nately, Wolverton with Ewhurst, Eastrop and Tadley respectively and annexed to their respective Parishes.

"That the inhabitants of such portions so to be separated shall be entitled to accommodation in the respective Parish Churches of the Parishes to which the portions are to be so annexed but shall cease to be entitled to any right of accommodation in the Parish Churches of the Parishes from which the several portions are respectively separated except never-
