

otherwise Northwich, in the County of Chester and in the Diocese of Chester, which is bounded upon the north and upon part of the west by the New Parish of Christ Church, Barnton, upon the remaining part of the west by the Parish of Weaverham, upon the south partly by the New Parish of Saint John, Hartford, and partly by a detached portion of the said Parish of Weaverham, upon the south east by the Consolidated Chapelry of the Holy Trinity, Northwich, all in the said County and Diocese, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing at the centre of the swing bridge which carries Hayhurst Street across the River Weaver where the boundaries of the said Consolidated Chapelry of the Holy Trinity, Northwich, of the Parish of Davenham, in the said County and Diocese, and of the said New Parish of Saint Helen, Witton, otherwise Northwich, all meet, and extending thence northward along the middle of the River Weaver for a distance of 68 chains or thereabouts to the boundary which divides the said New Parish of Saint Helen, Witton, otherwise Northwich, from the said New Parish of Christ Church, Barnton."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chester.
