Under the terms of the Royal Warrant amending the regulations of the Military Cross, dated 5th February, 1931, and by authority of the Royal Warrant dated 5th February, 1931, authorising the Army Council to restore certain decorations and medals awarded for gallantry which have been forfeited since 4th August, 1914, under the rules hitherto obtaining, and which would not have been liable to forfeiture under the new rules, the Army Council have restored the Military Cross to Mr. George Walter Bielby, and caused his name to be replaced on the Register of the Military Cross.
