UNEMPLOYMENT INSURANCE ACTS,
1920 TO 1931.

NOTICE OF PROPOSAL TO MAKE A SPECIAL ORDER VARYING AND AMENDING THE SPECIAL SCHEME OF UNEMPLOYMENT INSURANCE FOR THE INSURANCE INDUSTRY.

The Minister of Labour hereby gives notice that he proposes by virtue of the powers conferred upon him by Section 18 of the Unemployment Insurance Act, 1920, and all powers in that behalf, to make a Special Order further varying and amending the Insurance Industry Special Scheme.

Copies of the draft Special Order may be obtained on application in writing to the Assistant Secretary, Ministry of Labour, Employment and Insurance Department, Montagu House, Whitehall, S.W. 1.

Objections to the draft Special Order must be sent to the above address within 21 days from the twenty-second day of January, 1932.

Every objection must be in writing and must state:—

- (a) the draft Order or portions of the draft Order objected to;
- (b) the specific grounds of objection;
- (c) the omissions, additions or modifications, asked for.

VARIATION OF MINIMUM RATES OF WAGES FOR
FEMALE WORKERS.

The Stamped or Pressed Metal Wares Trade Board (Great Britain) have issued a Notice Q. (38) dated 21st January, 1932, setting out Minimum Rates of Wages for Female Workers as varied by the Trade Board and confirmed by Order of the Minister of Labour, to take effect as from 25th January, 1932, together with the Minimum Rates of Wages already in operation for Male Workers. These latter rates are unaffected by the variation.
