

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Burnley Rectory Act, 1890, do hereby, subject as hereinafter mentioned, grant to the Incumbent of each of the Benefices, all in the County of Lancaster and in the Diocese of Blackburn, whereof the names are stated in the first column of the Schedule hereto, and to his successors Incumbents of the same Benefice, one yearly sum or stipend of the amount stated in the second column of the said Schedule opposite to the name of the Benefice, such yearly sum or stipend to be payable out of the Burnley Rectory (Capital) Account in accordance with the provisions of the said Act and to be calculated as from the first day of November in the year one thousand nine hundred and thirty-one and to be receivable in equal half-yearly portions on the first day of June and the first day of December in each year: Provided that the yearly sum hereby granted is in case of deficiency of income of the said Burnley Rectory (Capital) Account subject to abatement in accordance with the provisions of the said Act.
