RURAL DISTRICT OF SAFFRON WALDEN.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the second day of February, 1932, the Minister of Health has declared that, on and after the twenty-second day of February, 1932, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Saffron Walden, namely:—

Section 30 (which relates to the repair and enclosure of dangerous places) comprised in Part II of the said Act.

The above provisions are declared to be in force subject to the conditions specified in the Order.
