## LAND DRAINAGE ACT, 1930.

Notice is hereby given that in pursuance of the powers conferred upon him by the before-mentioned Act the Minister of Transport has made Regulations under the short title of "The Land Drainage Act, 1930 (Prescription of Interest) Regulations, 1932," prescribing the persons who shall be deemed to have sufficient interest for the purpose of presenting a Memorial to the Minister that any Order made by him under the said Land Drainage Act shall not become law unless confirmed by Parliament.
