

ment of a Master shall thereupon devolve upon the Chancellor of the University; and forthwith after such appointment another Meeting of the Electors shall be convened (in the same manner as nearly as may be as is hereinbefore prescribed with respect to the original Meeting for electing a Master) at which the person appointed shall be present, and shall make the promise prescribed in Section 13 of this Chapter, and the senior Fellow present shall deliver to him a copy of the Statutes and a key of the Chest, and shall admit him to his office."

By deleting the word "Fellow" in Section 17 and substituting therefor the word "Elector".

By repealing Section 22 of the Chapter and substituting therefor the following Section to form an amended Section 22:—

"22. The Master shall retire on or before the 31st day of July next following his seventieth birthday, or if his birthday be the 31st day of July, on or before his seventieth birthday, but the Society may at a Meeting of the Electors under Section 3a by a two-thirds majority of all the Electors, continue a Master in the Mastership for a further period not exceeding five years, provided that if one whom the Society proposes to elect to the Mastership has on or before the date of his election attained the age of sixty-three but not the age of sixty-eight years, he may be elected for a period terminating on the thirty-first day of July following the expiration of seven years from the date of his election, and may by the majority already prescribed in this Section be continued in his Mastership until the thirty-first day of July next following his seventy-fifth birthday, or if his birthday be on the thirty-first day of July until his seventy-fifth birthday.

A retired Master shall have the status, rights and privileges of a Non-Stipendiary Fellow with seniority next after the Master, save that as provided in Section 1 of this Chapter he shall not be an Elector to the office of Master.

Nothing in this Section shall affect the rights of Mr. Arthur Hutchinson, the present Master, to continue in office until the ninth day of October next following his seventieth birthday."

CHAPTER III.

Of the Fellows.

By repealing Section 8 of this Chapter and substituting therefor the following Section to form an amended Section 8:—

"8. The Society shall have power to elect into Non-Stipendiary Fellowships (a) former holders of Stipendiary Fellowships who have ceased to hold any office qualifying them therefor; (b) former holders of Non-Stipendiary Fellowships under the two next preceding Sections who have ceased to hold any office qualifying them therefor; (c) a Master who has resigned under Section 17 of Chapter II; (d) (by a two-thirds majority of those present and voting at a General College Meeting) not more than one person, whether a member of any University or not, specially distinguished in Literature or Science."

By adding to Section 25, Sub-Section (c) at the end of the Sub-Section the words "Such re-election may be made at any date not more than one year before the expiration of the Fellowship."

CHAPTER IV.

Of the Scholars.

By adding to Section 3 of this Chapter the word "and" after the word "Scholars" and deleting the words "and Research Students".

By adding to Section 6 of this Chapter the word "Foundation" before the word "Scholarships" at the beginning of the Section.

By repealing Section 7 of this Chapter and substituting therefor the following Section to form an amended Section 7:—

"7. Entrance Scholarships or Exhibitions shall be awarded to candidates who are not members of the College or resident Members of the University on the results of open competitive examinations held for that purpose, or on the results of examinations recognized by the Board of Education for the award of Higher School Certificates. No award of an entrance scholarship shall be made to a candidate who attained the age of nineteen years before the first day of the month in which the examination began, except in one case in each academical year. No candidate shall be preferred to another on account of his place or birth or education, except that the Society may, having previously given due notice, impose restrictions for any award or awards in Modern Languages."

By repealing Section 9 of this Chapter and substituting therefor the following Section to form an amended Section 9:—

"9. An Entrance Scholarship or Exhibition (save as provided in Sections 12 and 13 of this Chapter) shall be tenable for one year (or, if the Society at any time so determine, for two years) after which such Scholar or Exhibitioner shall, unless the Society determine otherwise, succeed to a Foundation Scholarship or Exhibition of the same value.

A Foundation Scholarship or Exhibition (save as provided in Sections 12 and 13 of this Chapter) shall be tenable till the Scholar or Exhibitioner shall have attained sufficient standing to take the degree of Bachelor of Arts, and shall then terminate unless his tenure be extended under the next following provision."

By repealing Section 13 of this Chapter and substituting therefor the following Section to form an amended Section 13:—

"13. In any case which the Society in College Meeting shall deem to be one of grave fault, or of marked idleness, or of failure to attain a sufficiently high standard in his studies, whether as tested by any College or University examination or otherwise, they may deprive a Scholar, Exhibitioner or Research Student entirely of his Scholarship, Exhibition or Studentship, or may degrade a Scholar to a Scholarship of lower grade or to an Exhibition, or may reduce the emolument of a Research Student."
