MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT,
1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by

the Minister of Transport after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act, to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 518E) Provisional Regulations, 1932, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the operation of certain omnibus journeys on Route No. 518E (Cricklewood and Brent Station).

ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 29TH APRIL, 1932.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Application of Part II of the Sheep Scab
Order of 1928.*

1.—(1) Part II (*Restriction on Movement of Sheep out of a Movement Area*) of the Sheep Scab Order of 1928, hereinafter referred to as the "Principal Order," is hereby applied to the Area described in the Schedule hereto, hereinafter referred to as "the Area" and the Area so described shall be a "Movement Area" for the purposes of the Principal Order.

(2) This Article shall come into operation on the twenty-fourth day of July, and shall cease to operate on the tenth day of September, nineteen hundred and thirty-two.

Restrictions on Exposure of Sheep at Markets, etc., within the Area during the period from 24th July to 9th September (inclusive).

2.—(1) Sheep on any premises in the Area shall not (except as hereinafter provided) be permitted to enter, or be exposed for sale or exhibition in any market, fairground, sale-yard or place of exhibition in that Area during the period from 24th July to 9th September (inclusive), in the current year, unless they
