Now, therefore, in pursuance of the powers conferred to me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw as from to-day's date from the said Harold Ernest Gamlen (Junior) the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and to supply Raw Opium, Coca Leaves and Indian Hemp and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct as from the same date, that it shall not be lawful for the said Harold Ernest Gamlen (Junior) to give prescriptions for the purpose of the Dangerous Drugs (Consolidation) Regulations, 1928.

MERCHANDISE MARKS ACT, 1926.

REFERENCE TO STANDING COMMITTEE.

BIFURCATED AND TUBULAR RIVERS OF METAL.

In accordance with the provision of Section 2, Sub-Section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of an application received by them for the making of an Order-in-Council to require imported bifurcated and tubular rivets in all metals to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect thereof.

Attention is called to the fact that, while, under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also, at their discretion, consider and report upon the question whether such goods should bear an indication of origin at the time of importation.
