## TORQUAY.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Torquay (hereinafter called the Corporation), being the Urban Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Torquay Waterworks Act, 1856, as altered by a Provisional Order of the Local Government Board which was confirmed by the Local Government Board's Provisional Orders Confirmation (Ashton-under-Lyne, &c.) Act, 1879, so as:—

(1) To extend the limits of the Corporation for the supply of water by the inclusion within those limits of the following areas, namely:—

(a) the Parish of Milber in the Urban District of Newton Abbot;

(b) that portion of the Parish of Kingskerswell in the Rural District of Newton Abbot which is bounded on the North by the road from Moles Cross to Nut Bush Corner, on the East by the boundary between the Parish of Kingskerswell and the Borough of Torquay, on the West by the road from Gallow's Gate to Mole's Cross and terminating in the South at Gallow's Gate;

(c) that portion of the Parish of Coffinswell in the Rural District of Newton Abbot which is bounded on the North by the road leading from Newton Abbot to Haccombe Cross, on the East by Blackenway Lane, on the South partly by the boundary between the Parish of Coffinswell and the Parish of Abbotskerswell and partly by Milber Lane, and on the West by the boundary between the Parish of Coffinswell and the Urban District of Newton Abbot;

(d) that portion of the Parish of Coffinswell which is bounded on the North partly by the northern boundary of Fields Nos. 102, 53 and 50 on the Ordnance Survey Map of Devonshire, 1906 Edition and
