

of all motor vehicles other than motor cars adapted to carry not more than seven passengers exclusive of the driver, motor cycles and invalid carriages, on the unclassified road through the village of Airmyn, from its junction with Boothferry Road, at Boothferry Bridge, to its junction with Rawcliffe Road in the Rural District of Goole.

Provided that nothing in the Order shall prevent the driving upon the said road of

(i) any vehicle which is being used for the conveyance of persons and/or goods or merchandise to or from any house, building or other premises situate on or adjacent to the said road;

(ii) any vehicle which is being used in connection with the maintenance, improvement or reconstruction of the said road, or the laying, alteration or repair in or near to the said road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or any telegraph or telephone wires, cables, posts or supports;

(iii) any vehicle which is being used for the purposes of agriculture in connection with land adjoining or lying near to the said road or for the conveyance or haulage of timber felled upon such land.
