

"2. The scale of full pay of Quartermasters (Lieutenant and Captain) to be as follows:—

"4. The scale of retired pay for Quartermasters retired in the rank of Captain or Lieutenant after the date of this Order to be as follows:—

Captain or Lieutenant with 8 or less years' service since promotion to Lieutenant:—

"5. The standard rates of pay shown in paragraphs 2, 3 and 4 to be comparable with the standard rates authorised by Order in Council of 22nd January, 1920, and to be subject to review in like manner and on the same occasions as the standard rates of pay of Officers generally.

"6. Pension and gratuity for the widow of a Quartermaster with less than 8 years' service since promotion to Lieutenant retired on or after the date of this Order to be at the rates applicable to the widows of Lieutenants R.M.

"7. Nothing in these regulations shall be held to affect other Officers paid on the Quartermasters' scales, namely:—

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 19th day of August, 1932, (N. 2692/32), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 29th day of January, 1929, to sanction rates of extra duty pay to certain Royal Marine ranks when organised in service units:

"And whereas we consider it desirable that certain other Royal Marine ranks of the units should receive extra remuneration in their appointments, viz.:—

Sergeant in charge of Motor Transport Drivers—9d. a day (each working day).

Non-Commissioned Officer in charge of Slinging Detachment—1s. 0d. a day:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to authorise the payment of extra duty pay accordingly.
